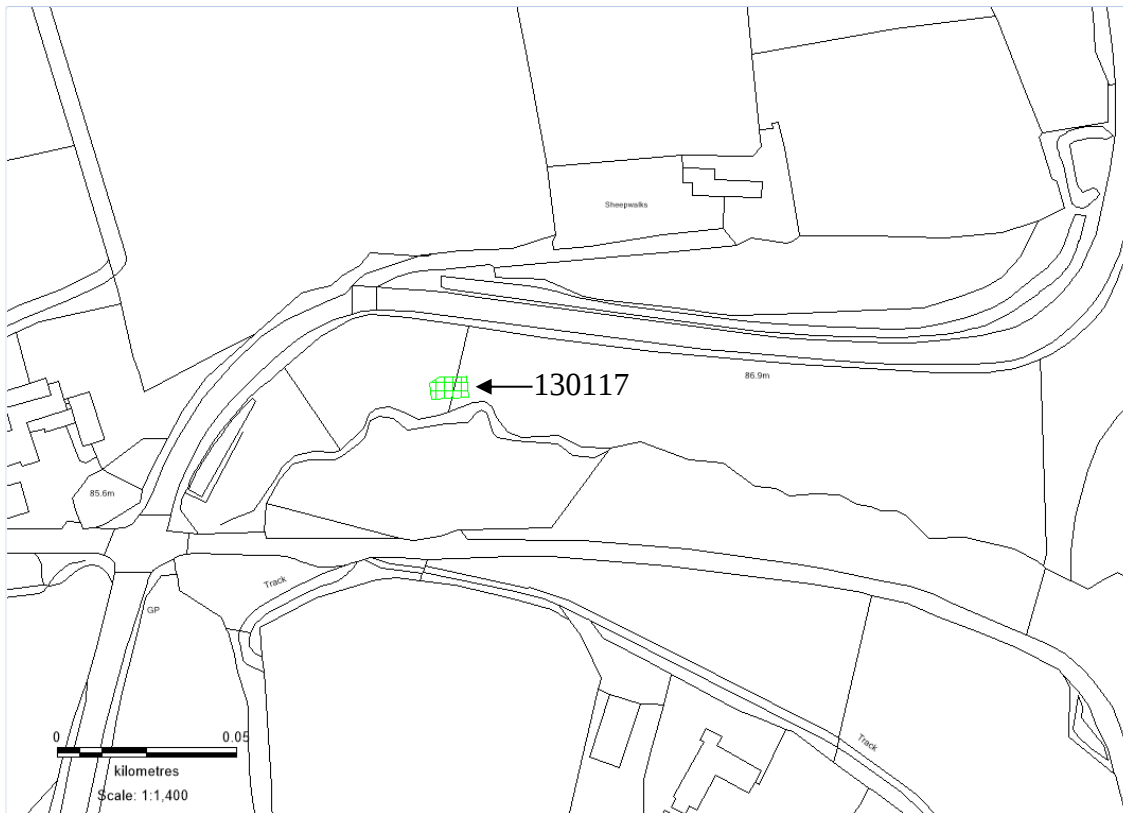

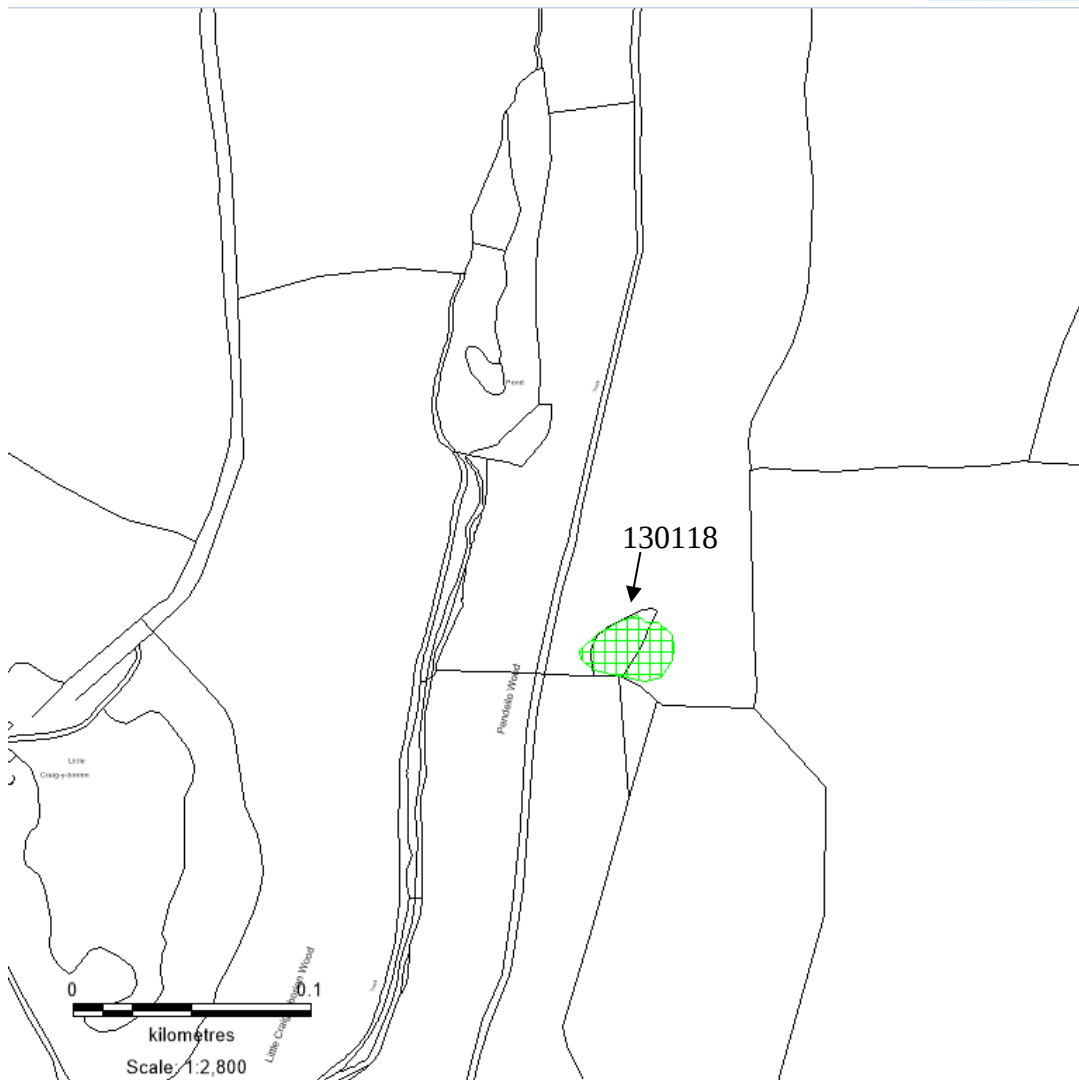

The Historic Maps record this area with broadleaf woodlands. Therefore, we recommend any restocking be with native broadleaf species.
