



NRW Screening Request FLA10 24-25

Thank you for your consultation regarding the felling licence application for Edwinsford Estate. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources. The following historic environment features are recorded within the consultation area:

- **Footbridge (PRN 126963)**: Marked on the 1st and 2nd edition 1:2500 Ordnance Survey Maps (NGR: SN5876733355). This footbridge may survive as ruins, earthworks, or below ground archaeology.
- Ford (PRN 126964): Also marked on the 1st and 2nd edition 1:2500
 Ordnance Survey Maps (NGR: SN5876633346). Similar to the footbridge, this ford may exist as ruins, earthworks, or below ground archaeology.

These features are located on the western periphery of the site and their current condition unknown. We advise that these historic environment features (labelled on the map) are protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Heneb – The Trust for Welsh Archaeology Heritage Management is informed and further information and advice can then be provided as required.
