## Proposed Woodland Creation (SM 8905 0795)

Thank you for your consultation regarding proposed woodland creation centred on NGR SM 8905 0795. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources. The following historic environment features are recorded within the consultation area:

- Stone (PRN 130123): Stone marked on the 1<sup>st</sup> edition 1:2500 Ordnance Survey Maps (NGR: SM 89475090). Current condition unknown.
- Stone (PRN 130124): Stone marked on the 1<sup>st</sup> edition 1:2500 Ordnance Survey Maps (NGR: SM 894008877). Current condition unknown.
- Thornbury (PRN 119664): Farmstead recorded on 2nd edition, 1:2500 Ordnance Survey map (NGR: SM8941808967).
- Hollybush (PRN 118985): Farmstead recorded on 2nd edition, 1:2500 Ordnance Survey map (NGR: SM8903508335).

The current condition of these features is unknown; however they may survive as ruins, earthworks or below ground archaeology. Therefore to comply with UKFS Forests and historic environment guidance, DAT advise that these historic environments (indicated on the map in orange and labelled with the PRN) must be protected from damage.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeology Heritage Management is informed and further information and advice can be provided as required.


