



**NRW Heritage Management Advice Request –
DFR/S/2024/0070 - Flood Risk Activity Permit Application**

Thank you for the Flood Risk Activity Permit Application consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the application lies close to the mill race feeding Glan-Gwydderig Woollen Mill. If the rip rap installation is going to affect the entry point of the race, Heneb, Dyfed region should be consulted.

PRN55253 POST MEDIEVAL MILL RACE SN7868334898
A mill race feeding Glan-Gwydderig Woollen Mill (PRN 28354), marked on the 1st edition Ordnance Survey map of 1888. A sluice lies at the northern end where it leaves the river Gwydderig at a weir (PRN 55252).
