The current condition of this feature is unknown; however, it may survive as a ruin, earthworks or below ground archaeology. We advise that the historic environment feature (labelled on the map above and marked with a green polygon) is protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

Bwlch Sais lies within an area rich in prehistoric activity. Although we have no other records within the consultation boundary, apart from the linear spread of stone, there is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Heneb – The Trust for Welsh Archaeology, Heritage Management Dyfed region is informed and further information and advice can then be provided as required.
