Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following feature within the proposed scheme.

PRN 18185 POST MEDIEVAL BRIDGE SN65532794

In addition, I wanted to flag up the following two features located approximately 100m to the west of the proposed scheme:

PRN 18187 POST MEDIEVAL MILL SN65402792

The site of Felin-wen, recorded as a corn mill by the RCAHMW (NPrn 24822) is shown on the 1st and 2nd edition Ordnance Survey maps. A leat (PRN 105483) runs north-south from the nearby River Dulas to the southwestern end of the main building.

PRN 128951 ORCHARD SN65372791

Orchard marked on 1st edition OS historic mapping.

The current condition of these features is unknown; however, they may survive as a ruins, earthworks or below ground archaeology. We advise that this historic environment features (labelled on the map) are protected from damage during operations.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Heneb – The Trust for Welsh Archaeology, Heritage Management Dyfed region is informed and further information and advice can then be provided as required.
