## EIA (Agriculture) Consultation T037 2024 Newcastle Emlyn

I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the consultation lies within the Historic Landscape Character Area, Rhos Penboyr. This landscape includes Crug Gorllwyn Round Barrow (CM108), located south of the application area.

I also note the following features.

PRN14911 EARTHWORK SN3177134901 Field called Bank war Ffordd in 1840-1 on tithe map. Feature appears as a curving length of cropmark or earthwork on AP's. KM Jan-94.

PRN130848 MERIBAH POST MEDIEVAL COTTAGE SN3180733977 "Fron-wen" cottage recorded on 1st Edition Ordnance Survey Map. A. Powell 2024.


The historic maps record clear field boundaries. These hedgerows are significant historic features and integral to the Historic Landscape Character. Therefore, it is important they should be retained.



There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Heneb – The Trust for Welsh Archaeology, Heritage Management Dyfed region is informed and further information and advice can then be provided as required.
