NRW Heritage Management Advice Request – DFR/S/2024/0114 - Flood Risk Activity Permit Application

Thank you for the Flood Risk Activity Permit Application consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the consultation lies within the Historic Landscape Character Area of Pembroke within the Registered Historic Landscape Area Milford Haven Waterway HLW (D) 3.

I also note the following features.

PRN60314 THE MILL BRIDGE POST MEDIEVAL ROAD BRIDGE SM9834001643 Grade II listed bridge.

PRN4515 PEMBROKE OLD CORN MILL POST MEDIEVAL CORN MILL SM98330163 19th century corn mill in the centre of Pembroke town.

Built in the early 19th century replacing PRN 29536 although still using the same bridge/dam PRN 20035. A large 4-storey block stood over the millrace which pierced the bridge. The building was in use up until WWII but was gutted by fire in 1956 and demolished to ground level in 1968. NL 1993 The walls of this mill, situated on the bridge/dam 20035 stand to c.1m above road level. The rest of the structure has been demolished. KM 1997

PRN46867 CUSTOM HOUSE POST MEDIEVAL CUSTOM HOUSE SM98330165 Small, single storey building of trapeziodal plan.

PRN43998 MILL BRIDGE FLOOD GATE POST MEDIEVAL FLOOD LOCK SM9835001660 Identified from OS 1st ed RJ 2002.



The current condition of these features is unknown; however, they may survive as a ruin, earthworks or below ground archaeology. We advise that the historic environment features (labelled on the map above and marked with a red dot) are protected from damage during operations.

As this is a grade II listed structure, consent and details must be approved by the conservation officer at Pembrokeshire County Council. We have no further comments to make.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Heneb – The Trust for Welsh Archaeology, Heritage Management Dyfed region is informed and further information and advice can then be provided as required.
