The recorded archaeology within this area is rich and important included are a series of prehistoric monuments and Scheduled round cairns, southwest of the application area. Intervisibility between these features was an important aspect of their use.</p> <p>https://dyfedarchaeology.org.uk/HLC/Myddfai/area/area231.htm</p> <p>The HLCA description and historic maps record the area was previously agrarian in nature, interspersed with mainly broadleaved woodland. Very few conifer plantations are recorded on the 1st edition Ordnance Survey maps of the late 19th century.</p> <p>We recommend that to assess the impact of woodland creation on the HLCA, and the potential for further unrecorded archaeology, the consultation area be subject to a desk-based assessment. Please contact Heneb Heritage Management Dyfed Region for further advice.</p>

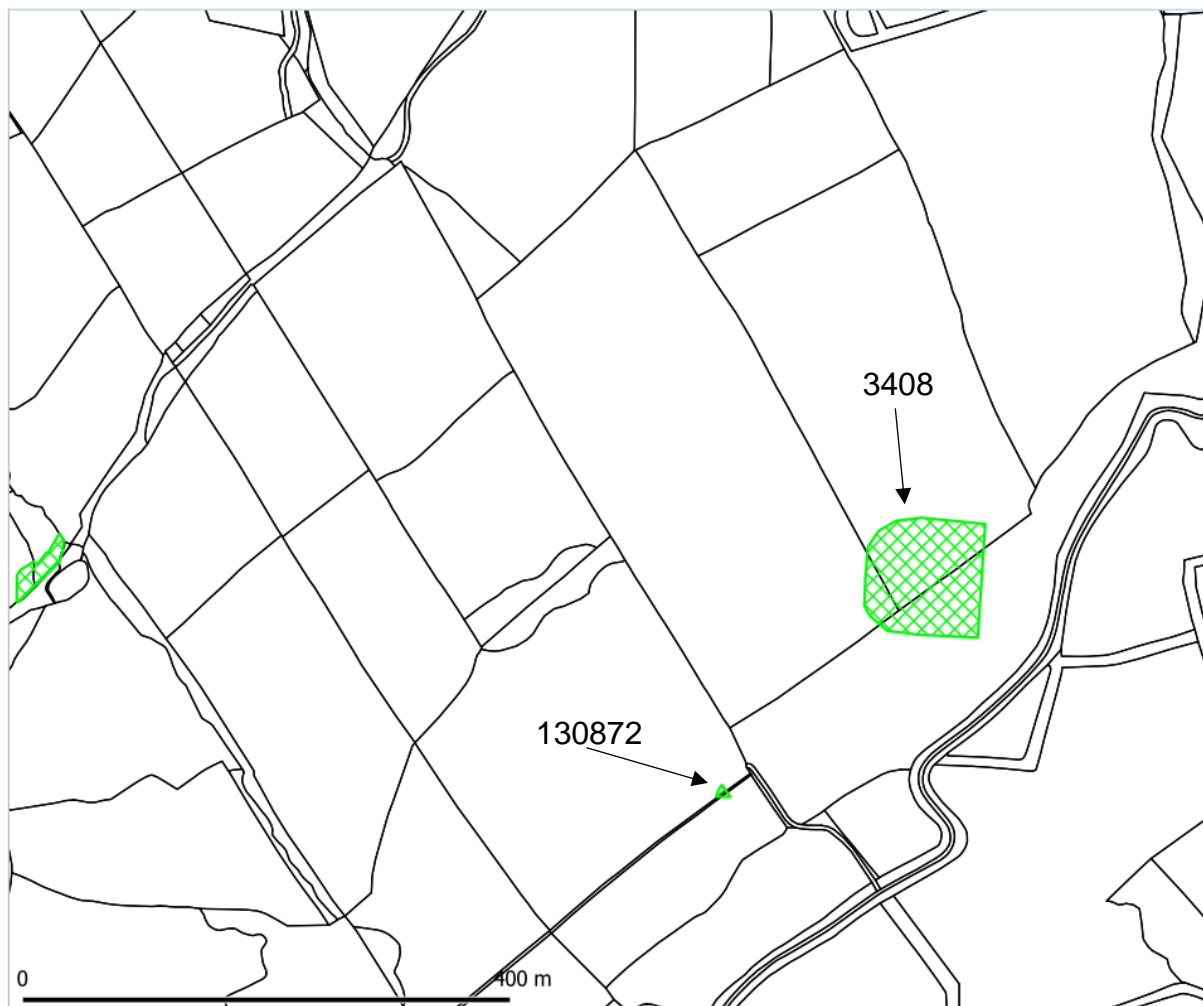

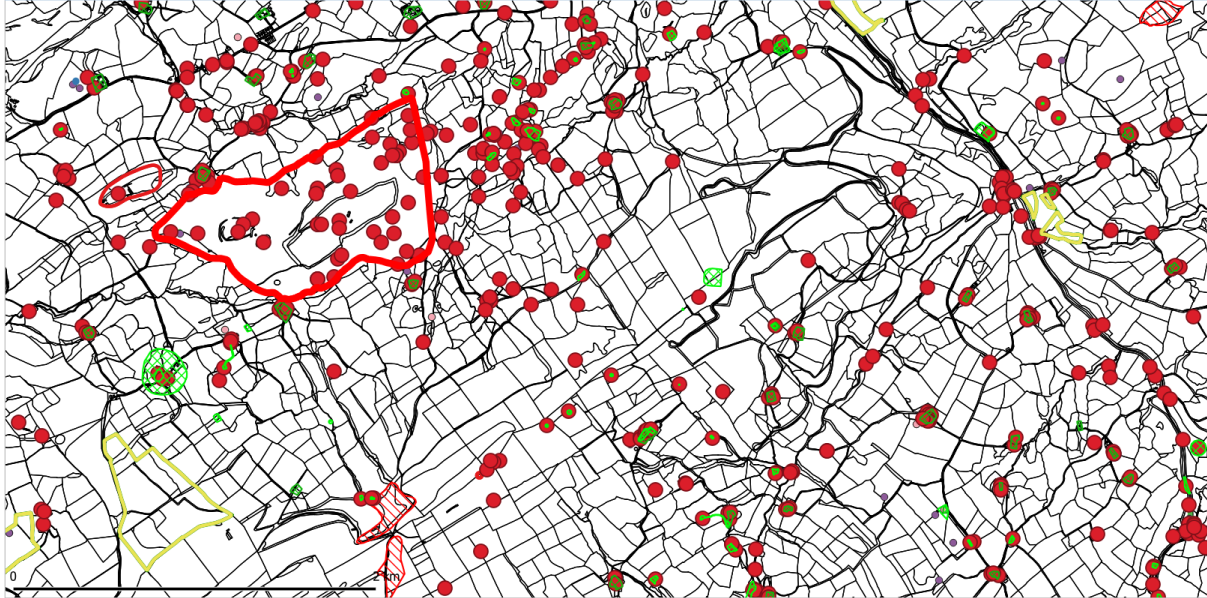
