NRW Screening Request FLA141 24-25 Llwyn y Brain Woodlands

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the consultation lies within the Historic Landscape Character Area Llanwrda Parish. This area is described with numerous small stands of deciduous woodland (particularly distinctive on the steep valley sides) and medium-sized conifer plantations lend a wooded aspect to the landscape.

I also note the consultation is adjacent to a recorded enclosure.

PRN4077 CILFFARA-FAWR POST MEDIEVAL ENCLOSURE SN729335 An enclosure which is roughly circular in shape and distinctive in the surrounding field pattern. It lies on a northeast facing slope between the 120m to 80m contour below the local summit of Cilffara Fawr to the west. It may preserve the outline of an earlier enclosure, but at present its origin is certain.

We advise that this historic environment feature (labelled on the map above and marked with a green polygon) is protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

The historic maps record the consultation area with a scattering of broadleaf trees. Therefore, we recommend that any restocking be with native broadleaf species.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Heneb – The Trust for Welsh Archaeology, Heritage Management Dyfed region is informed and further information and advice can then be provided as required.
