

Morewoods Screening Request MWA3980 near Trimsaran

Thank you for the Morewoods screening request MWA3980 near Trimsaran. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and there are no known historic environment features recorded within the consultation area.

However, the historic maps record a track north of the consultation area. This track is connecting colliery features and should be retained. We do not know the condition of this feature, therefore care should be taken so it is not disturbed during forestry operations.

I also noted two anomalies spotted during Lidar screening. Care should be taken in these areas (marked on the map below) during forestry operations and Heneb would appreciate receiving any information on the nature of these unknown features.
