Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and noted the following features.

PRN52877 POST MEDIEVAL MILL RACE SN3332727496
Mill race associated with corn mill (PRN 15810).

PRN52879 POST MEDIEVAL FOOTBRIDGE SN3332127211
A footbridge marked on the 1st edition Ordnance Survey map of 1888. 'Fords' are also marked here on the 2nd edition map of 1906.

PRN100037 PENRALLT VANGOR HOUSE POST MEDIEVAL COTTAGE SN33292726
A building and enclosure are marked in outline at this location on the Ordnance Survey 1st edition map (1888), possibly identifying the site of a former cottage. Present condition unknown. Penrallt Vangor House recorded on the Plan of the parish of Abernant in the County of Carmarthen, Tithe Map, 1841. A. Powell 2024.

PRN118193 MODERN WEIR SN33412779
A weir and sluice are marked on the 2nd edition OS map, indicating the point where water is extracted for the mill race PRN 52877 to supply the corn mill PRN 15810 Melin Pen-y-Caerau. A Pyper May 2020.

PRN130884 PENCAERAU MILL POST MEDIEVAL FORD SN3331027214
Fords recorded on 2nd Edition Ordnance Survey Map. A. Powell 2024.

PRN130885 NANTYROLCHFA POST MEDIEVAL WEIR SN3344427801
Weir recorded on 2nd Edition Ordnance Survey Map. A. Powell 2024.

PRN130886 NANTYROLCHFA POST MEDIEVAL FOOTBRIDGE SN3340027771
Footbridge recorded on 2nd Edition Ordnance Survey Map. A. Powell 2024.






