NRW Screening Request FLA181 24-25 Cresselly Barn Farm

Thank you for your felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note the consultation lies within the Registered landscape Milford Haven Waterway HLW (D) 3.

This is an archaeologically sensitive landscape with an extensive list of recorded features. The Lidar also indicates several unrecorded anomalies, possibly coal shafts. Therefore, in order to comply with the UKFS and Tree Felling Licence environmental conditions (The Licence holder must not damage historic features on the site; Annex 1 - Baseline Conditions), we advise that a site visit will need to be carried out to advise the suitable methodology for the felling and extraction of trees to protect the archaeology.

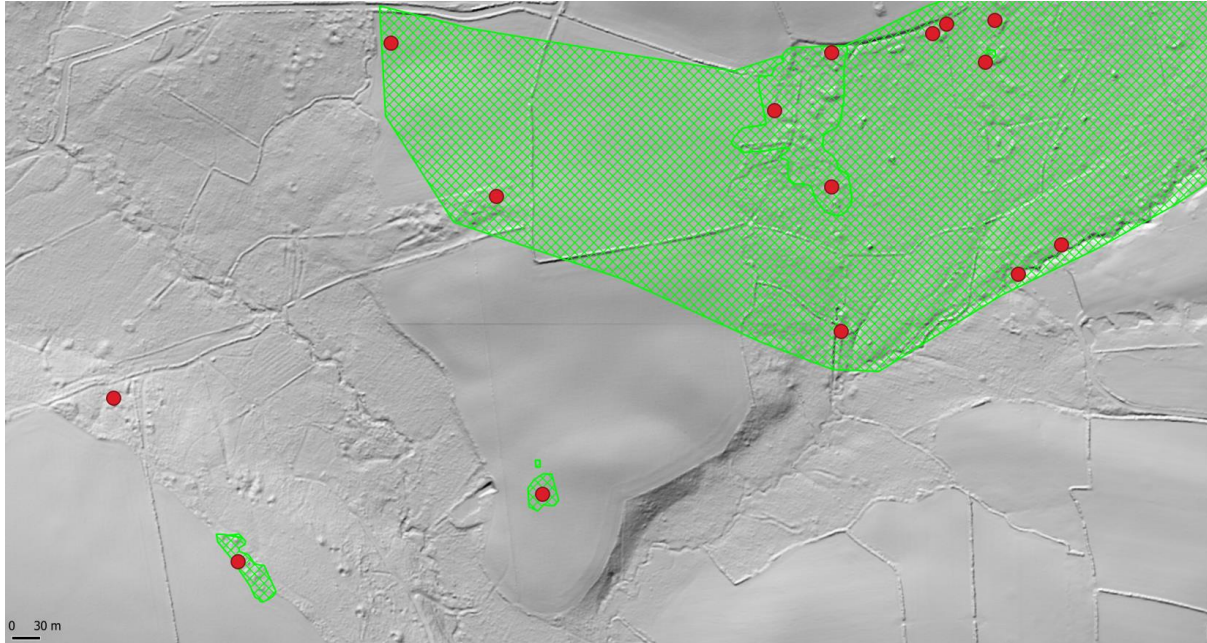

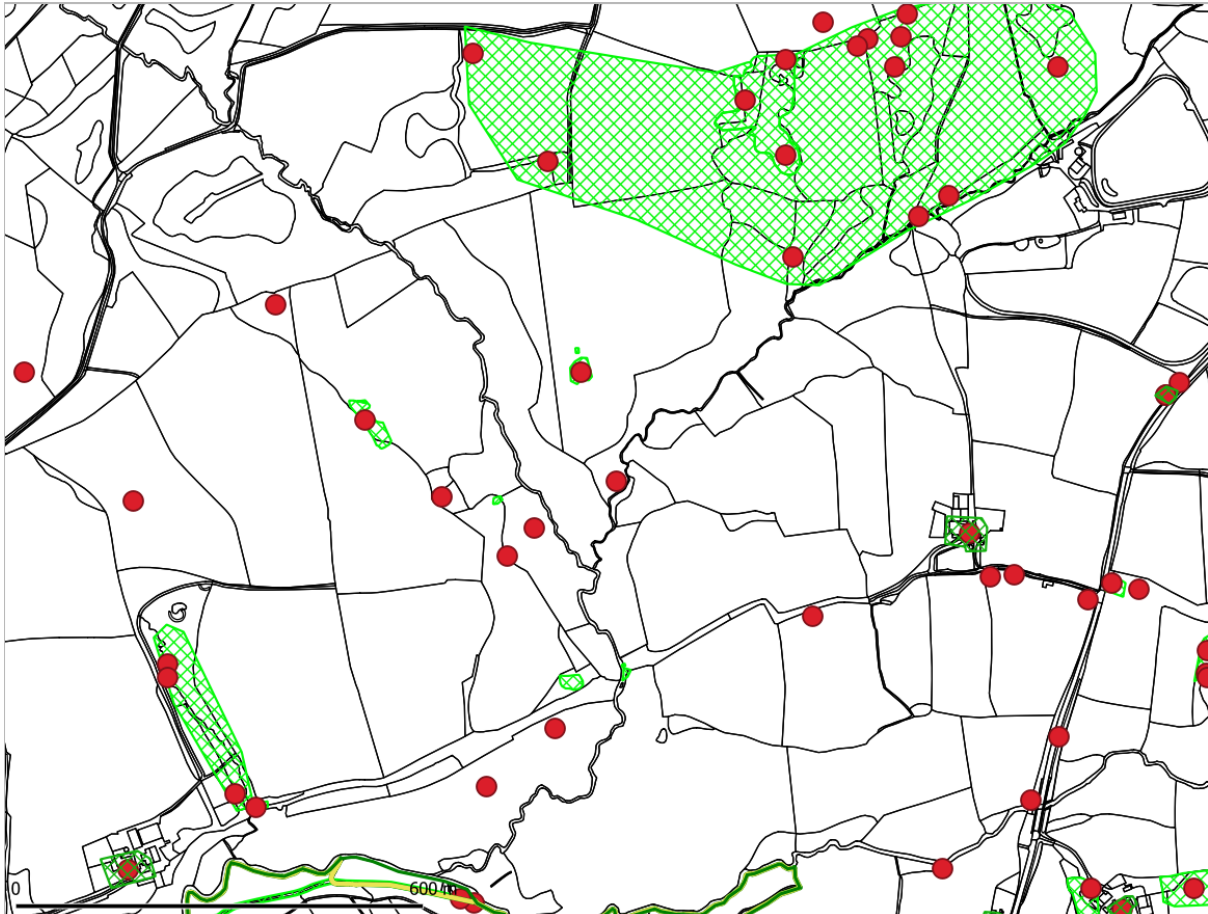
