## NRW Screening Request FLA212 24-25 Blaenduad near Cwmduad, Carmarthenshire

Thank you for the felling licence consultation. I have reviewed the map boundaries against the regional Historic Environment Record (HER) and other sources and note that compartment 5c1 includes the Scheduled Monument, Gareg Hir Standing Stone (CM202) therefore Cadw must be consulted. I am copying this response to Louise Mees, Inspector of Ancient Monuments and Archaeology (South West Wales).

I also note the following features.

PRN5392 CRUG WAUN BRONZE AGE ROUND BARROW SN40643376 No archaeological traces of a monument exists in the area indicated by the grid reference, nor in the immediately surrounding area. Site destroyed. When originally built, this barrow was c. 80m NNE of standing stone 1803 and marked the start of a whole series of barrows either side of, and following the course of, the Afon Duad to the SW. N Bestley PFRS 2001





We advise that these historic environment features (labelled on the maps above and marked with a green polygon and or red spot) be protected from damage during forest operations, to comply with UKFS Forests and the historic environment guidance.

Cadw will advise on the scheduled area of CM202 and its setting. When restocking in the vicinity of the scheduled monument a deciduous tree buffer is recommended to provide a permanent buffer around the feature to protect it from forestry operations.

The consultation areas are part of a rich prehistoric landscape, with recorded round barrows, standing stones, chambered tombs and several scheduled monuments (SM) which in prehistory would have intervisibility between features. This should be a consideration in the future restocking of this area.
