Building recorded on the parish of Llandybie in the County of Carmarthen tithe map, 1842. A. Powell 2025.





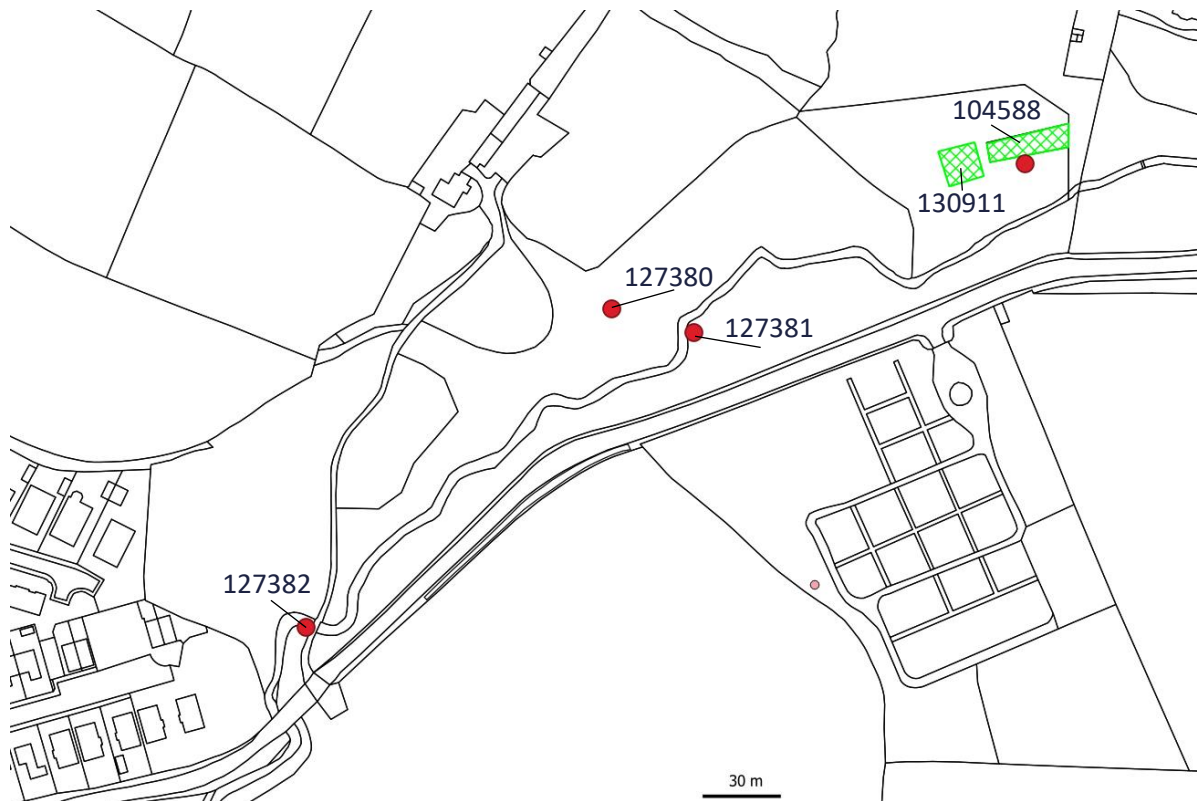
