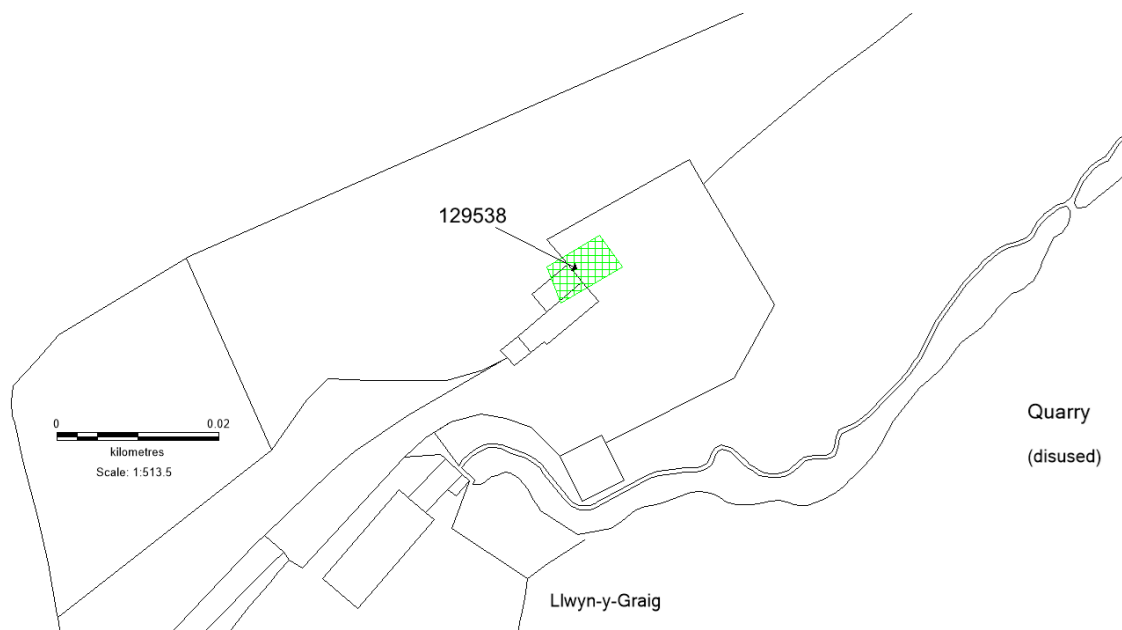
**NRW Screening Request FLA 78 23-24
