

Morewoods Screening Request MWA4165 near Llangolman

Thank you for the Morewoods screening request MWA4165 near Llangolman. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and there are no known historic environment features recorded within the consultation area. Although, the consultation lies within the Historic Landscape Character Area, Llangolman, in the Registered Landscape, Preseli HLW (D) 7.

The historic maps record a scattering of stones at the southeast end of the consultation. LiDAR and satellite images show two distinctive stones in this area, these features may be glacial erratics. Heneb would appreciate receiving any information on these features, such as photographs or a written description.
