**EIA (Agriculture) Regulations - Consultation Request  
T049 2023 North of Carew**

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and there are no known historic environment features recorded within the consultation area. Although, the site is near to the Scheduled Monuments Carew Castle (PE001) and Carew Bridge (PE083), therefore Cadw must be consulted. I am copying this response to Louise Mees Inspector of Ancient Monuments and Archaeology (South West Wales).

The consultation also lies within the HLCA West Williamson and Carew Newton in the HLA Milford Haven Waterway HLW (D) 3. Aerial photography has revealed a possible crop mark in the field parcel west of the consultation area and to the north are recorded post medieval quarries and limekiln.
