

A small cottage and enclosure is shown on the 1st edition Ordnance Survey map (1889). The aerial photographs from 2009 show the cottage has been cleared and the enclosure incorporated into the adjacent field.

The proposals for land-spreading of waste should not have a detrimental impact on this feature, which now exhibits no above ground remains,. However there may still be archaeological deposits surviving in this area, so ground intrusive activities should be avoided.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
