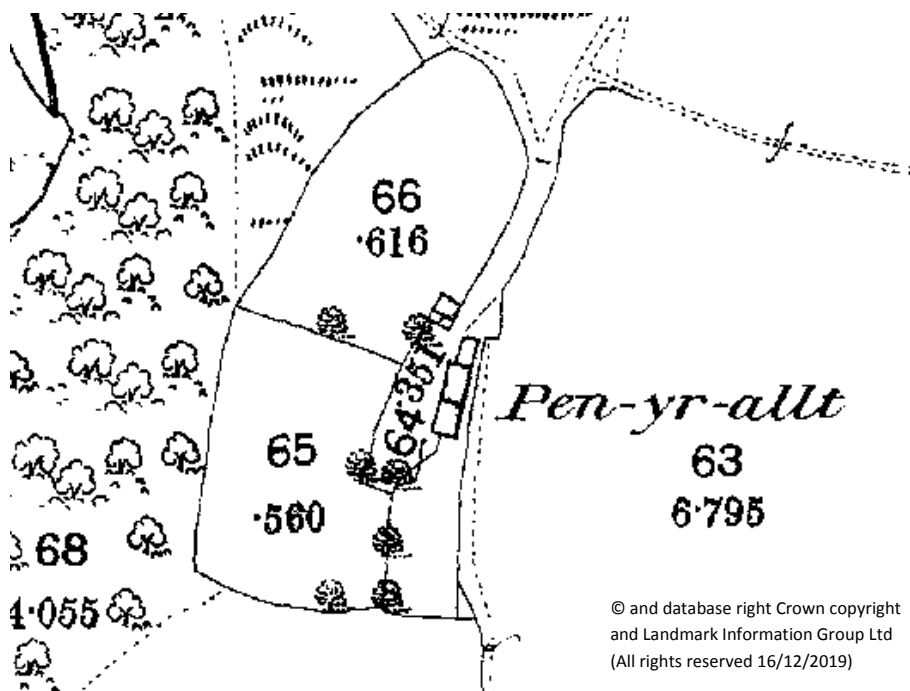
There are no records of any significant historic environment features within the affected area.

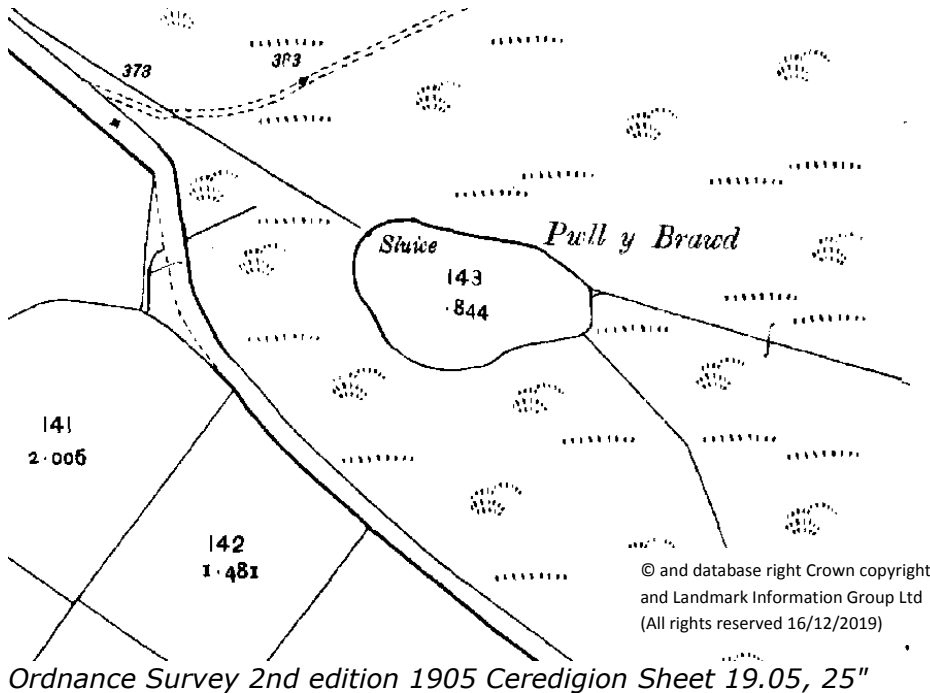

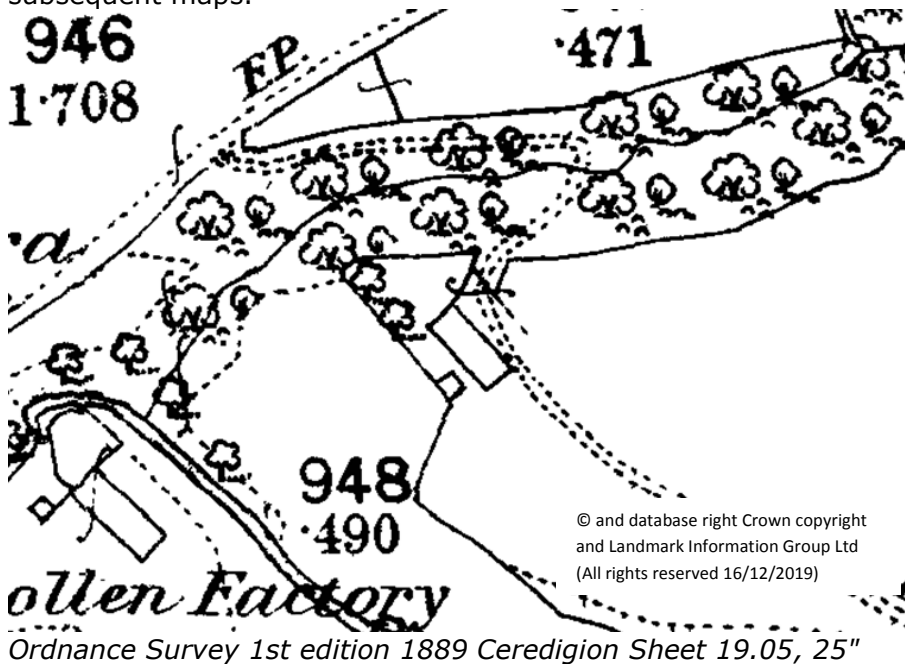
PRN 94765 PWLL Y BRAWD POND SN49146404
