EIA (Agriculture) Regulations - Consultation Request

Thank you for your EIA screening request, I have checked your map boundaries against the regional Historic Environment Record and other sources and have identified the following historic environment features:

PRN 118194
SITE TYPE POND
NGR SN37133533

A pond with sluice is marked on the 2nd edition OS map (1906) which suggests provision of water to power a water-wheel within the adjacent farmstead Pen-clawdd-uchaf. A Pyper 2020

PRN 118195
SITE TYPE COTTAGE
NGR SN6965388573

A rectangular structure within a three sided enclosure is recorded on the 2nd edition OS map (1906), suggesting a relict cottage at this location. A Pyper 2020

The consultation area also lies within the Drefach Felindre Registered Landscape of Special Historic Interest HLW (D) 10 which has been further subdivided into character areas. This holding lies within 3 Historic Landscape Character Areas; HLCA 385 Llangeler, HLCA 387 Bwlch-Clawdd – Cwmbach and HLCA 388 Rhos Penboyr. We do not have any information on the current condition of these features which may only survive as earthworks or below ground remains. In order to protect any archaeological evidence activities which might impact on these features should be avoided.

Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can be provided as required.

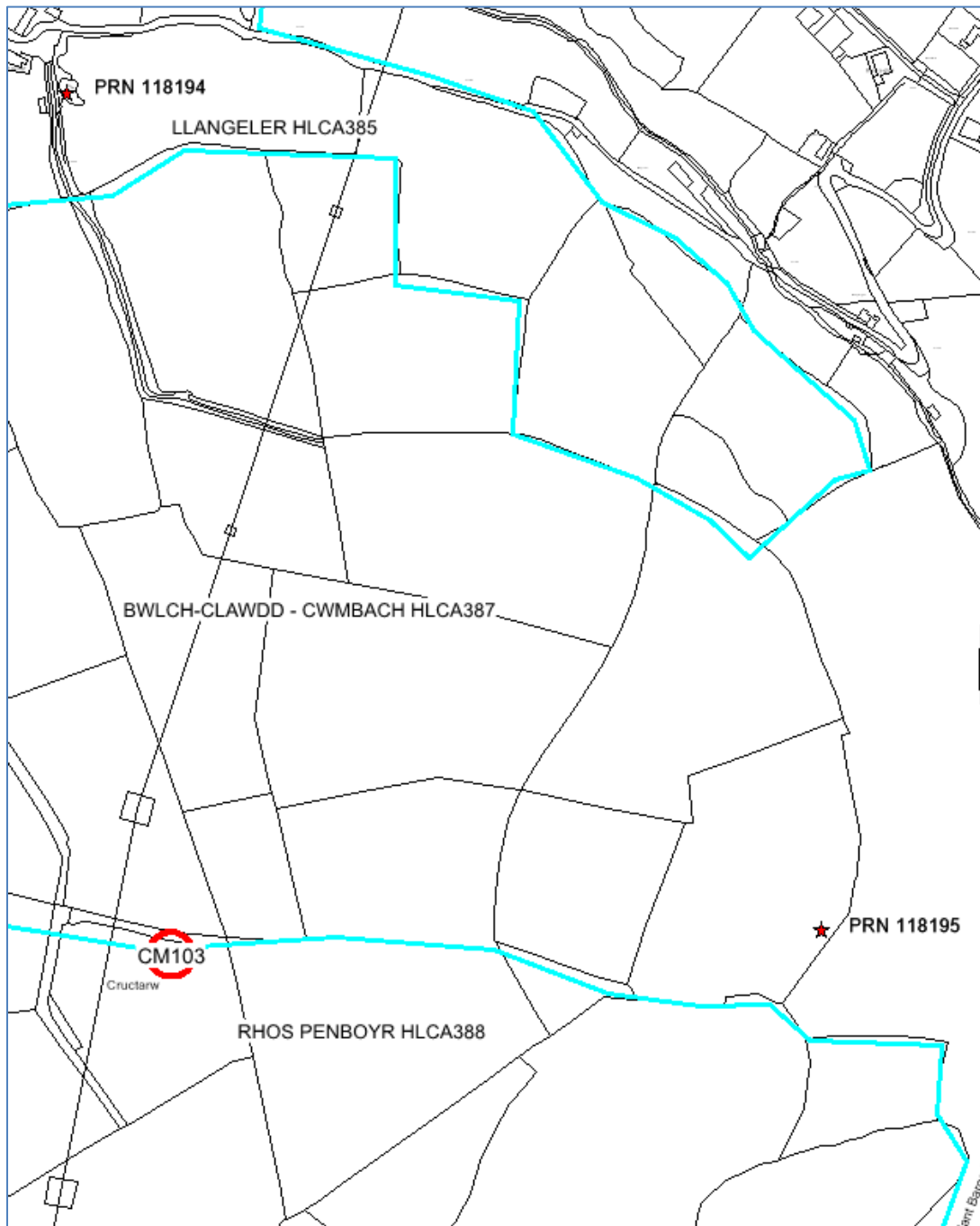
