Dear Laura,

Thank you for consulting us on the Sands of LIFE project proposals at Pembrey Burrows and Pendine. As regional archaeological curators the Heritage Management teams at Dyfed (DAT-HM) provide information, advice and assistance in understanding, appreciating and managing the historic environment and we welcome the opportunity to provide information at the earliest opportunity to include in your plans.

The Welsh archaeological trusts hold the regional Historic Environment Records (HER) which contain information on all known sites and artefacts of archaeological and/or historical interest ranging in date from the earliest known human habitation up to the end of the Cold War. It also contains information on archaeological work carried out. The HER is a dynamic record and is updated constantly when new information becomes available.

Pembrey Burrows; I have completed a screening on the consultation area you have supplied.

The following advice is in reference to the area beyond that which has been subject to the planning application S/40799. This screening therefore does not supersede the advice of the planning authority.

This much wider area of consultation has a range of sites recorded from prehistoric shell middens, to the later use of the site as a military testing establishment. This later phase of use has not yet been fully archaeologically assessed.

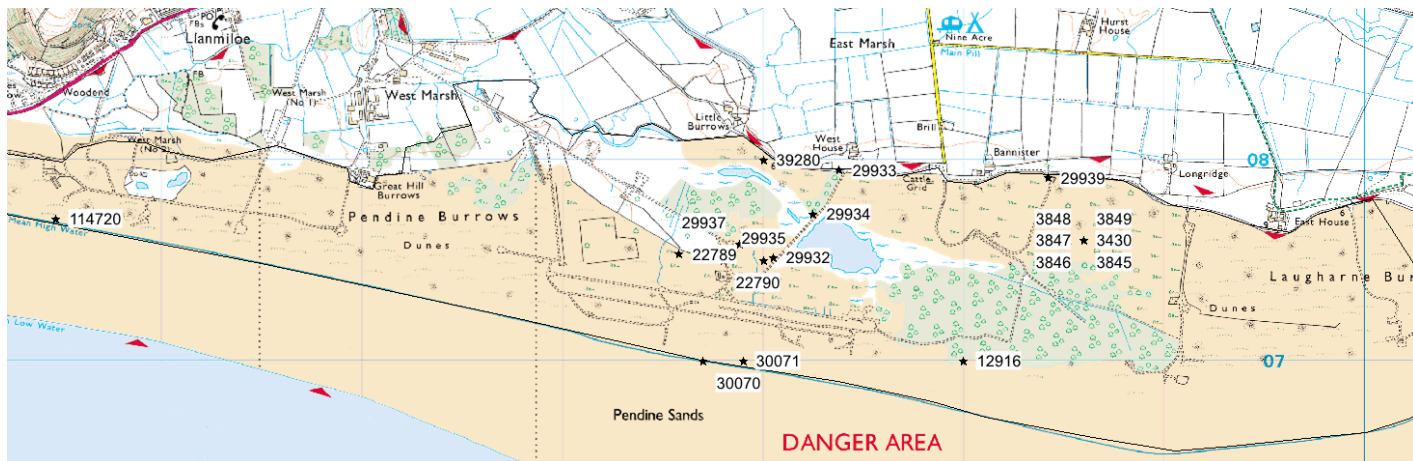
