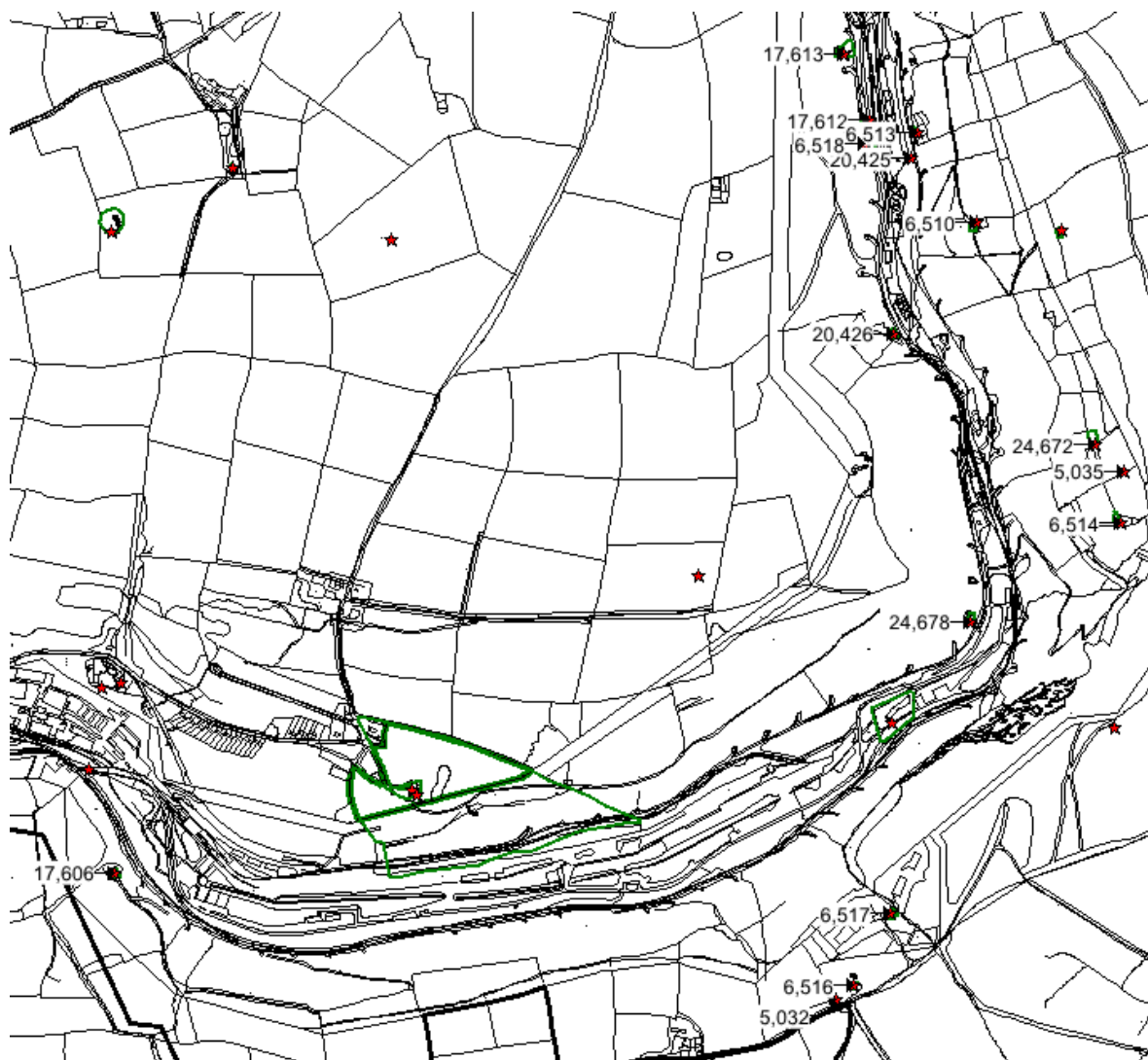

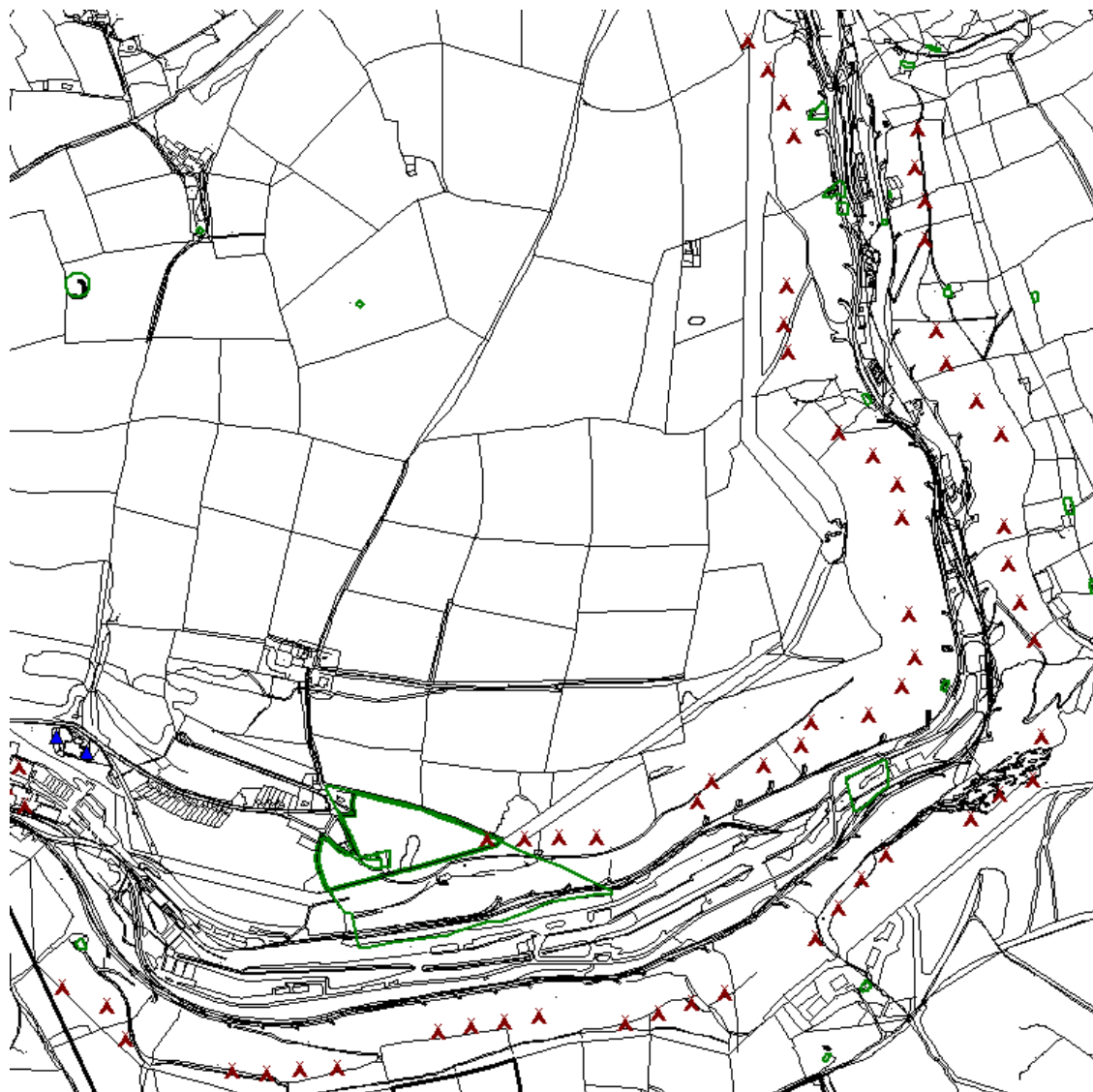

Whilst the underground magazines are unlikely to be affected, there may be associated remains, access roads and railways which may be affected by forestry operations. We would welcome further information and consultation regarding the methodology and approach to the proposals in order to provide further advice.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
