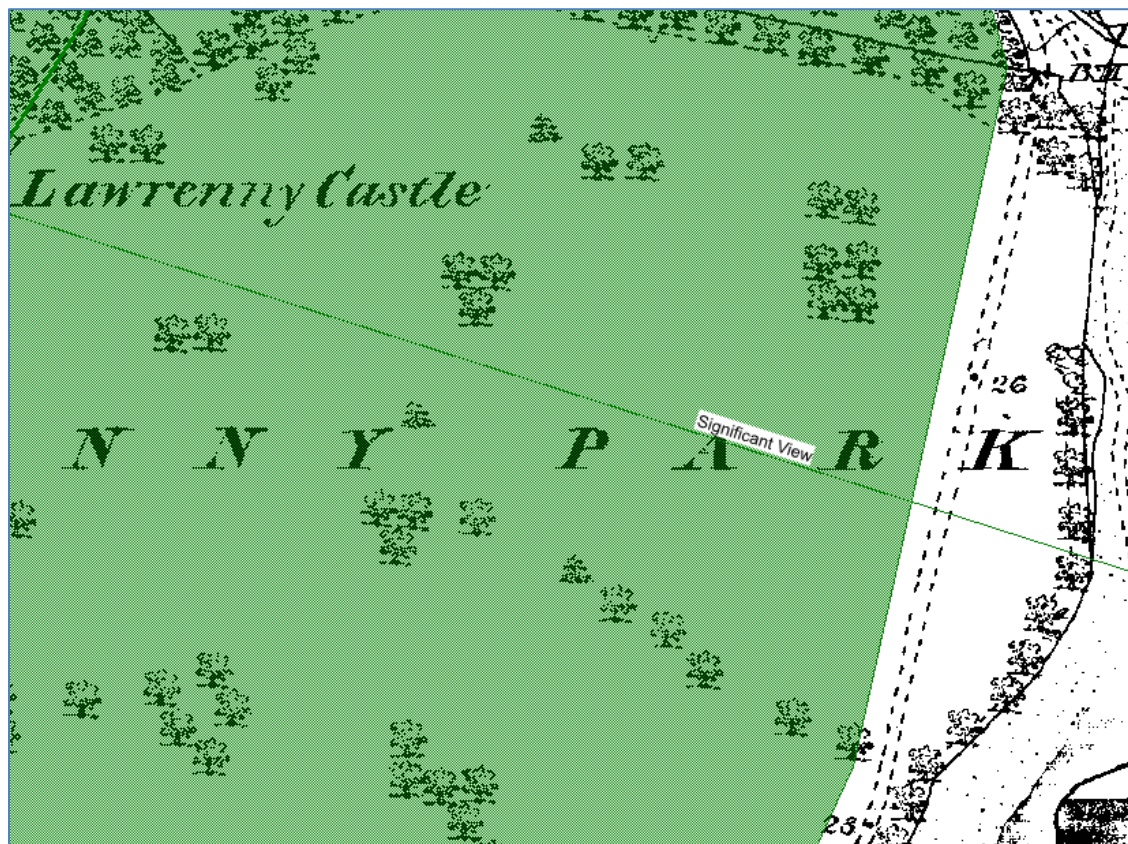

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note that the consultation area lies just beyond the Grade II Registered Historic Park and Garden of Lawrenny, (PGW (Dy) 36(PEM)). Historic mapping shows that woodland parcel is historically part of the parkland and also lies directly on the sightline of a significant view from Lawrenny Castle

We therefore recommend that restocking should follow an appropriate planting scheme to restore the historic parkland character, using an appropriate species profile and planting design.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
