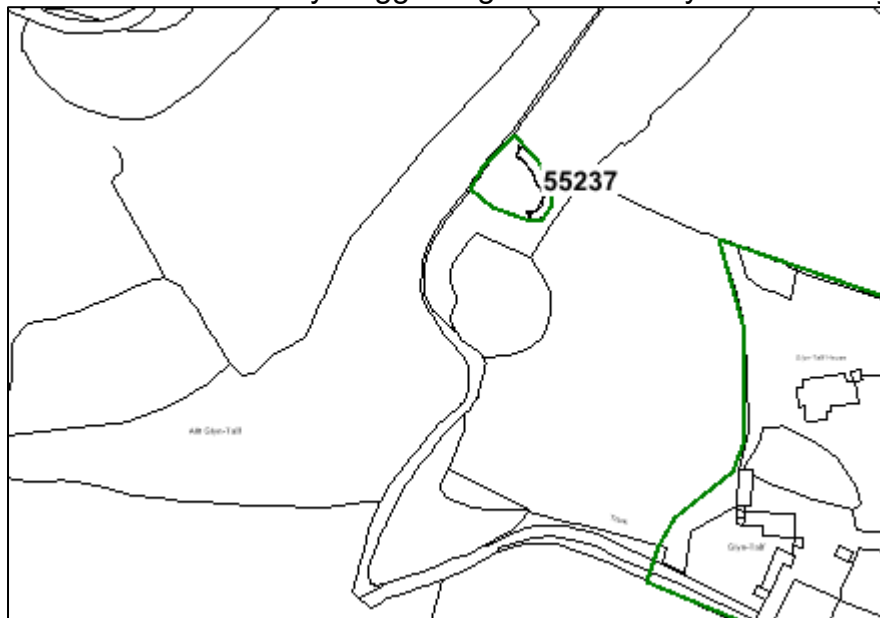

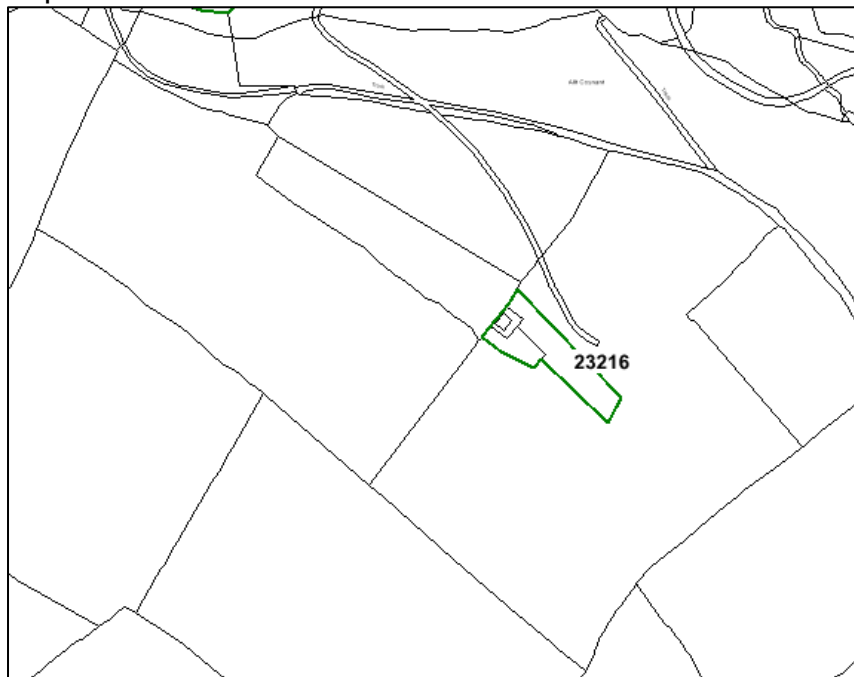
A small quarry marked on the 1st edition Ordnance Survey map of 1889.
