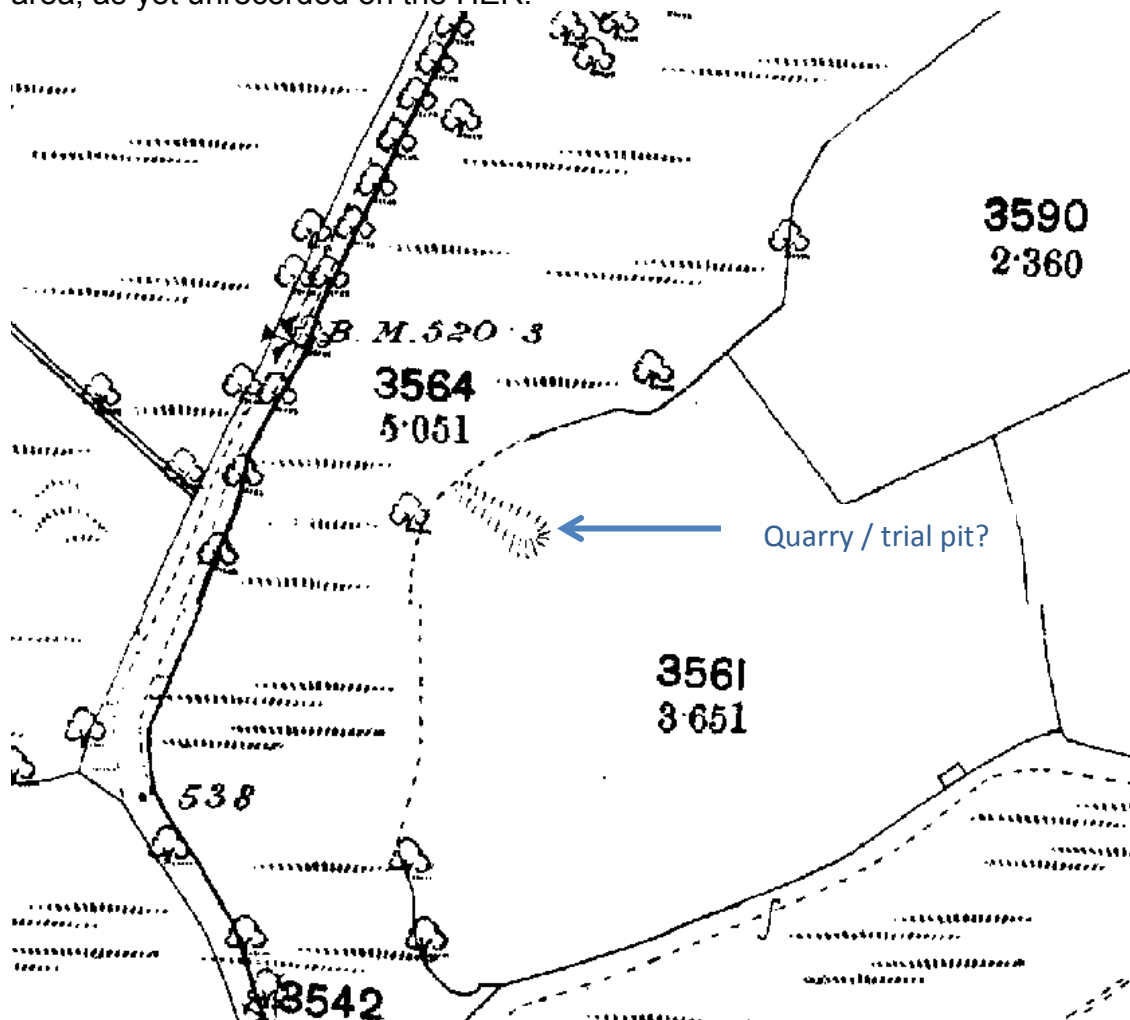

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and whilst there are no recorded Historic Environment assets within the consultation area, historic maps indicate a possible quarry or mining feature within the woodland area, as yet unrecorded on the HER.

Forestry operations should avoid causing damage to any earthwork features which survive.

The consultation area lies within the Registered Landscape of Outstanding Historic Interest, Tywi Valley (HLW (D) 5) and the Historic Landscape Character Area (HLCA) 203: Allt Tregyb (<http://www.dyfedarchaeology.org.uk/HLC/HLCTowy/area/area203.htm>). The proposal to restock the woodland with broadleaves would be in keeping with the Historic Landscape character.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
