Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and there are no recorded historic environment features within the consultation area, however historic maps show a farmstead, Gilfach, and a possible quarry or mining feature, within the consultation area. We do not know the current condition of the farmstead, but it is presumed ruinous.

Forestry operations should avoid damaging the remains of this farmstead and quarry feature and any associated structures. The landscape is shown on historic maps to be a patchwork of fields, and boundary banks are likely to remain as low earthworks. These should also be protected from damage where possible.


