Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note a cottage or small farmstead, Llwyn Piod, PRN 22602. Its current condition is unknown, but it is presumed to be ruinous. Forestry operations should avoid damage to any remaining structures or earthworks.

The consultation area lies within the Registered Landscape of Special Historic Interest, Drefach and Felindre (HLW (D) 10) and the Historic Landscape Character Area (HLCA) 382: Dyffryn Bargoed (<http://www.dyfedarchaeology.org.uk/HLCA/drefachfelindre/dyffrynbargoed.htm>). The proposal to thin the wood will not have a detrimental impact on the Historic Landscape character.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.

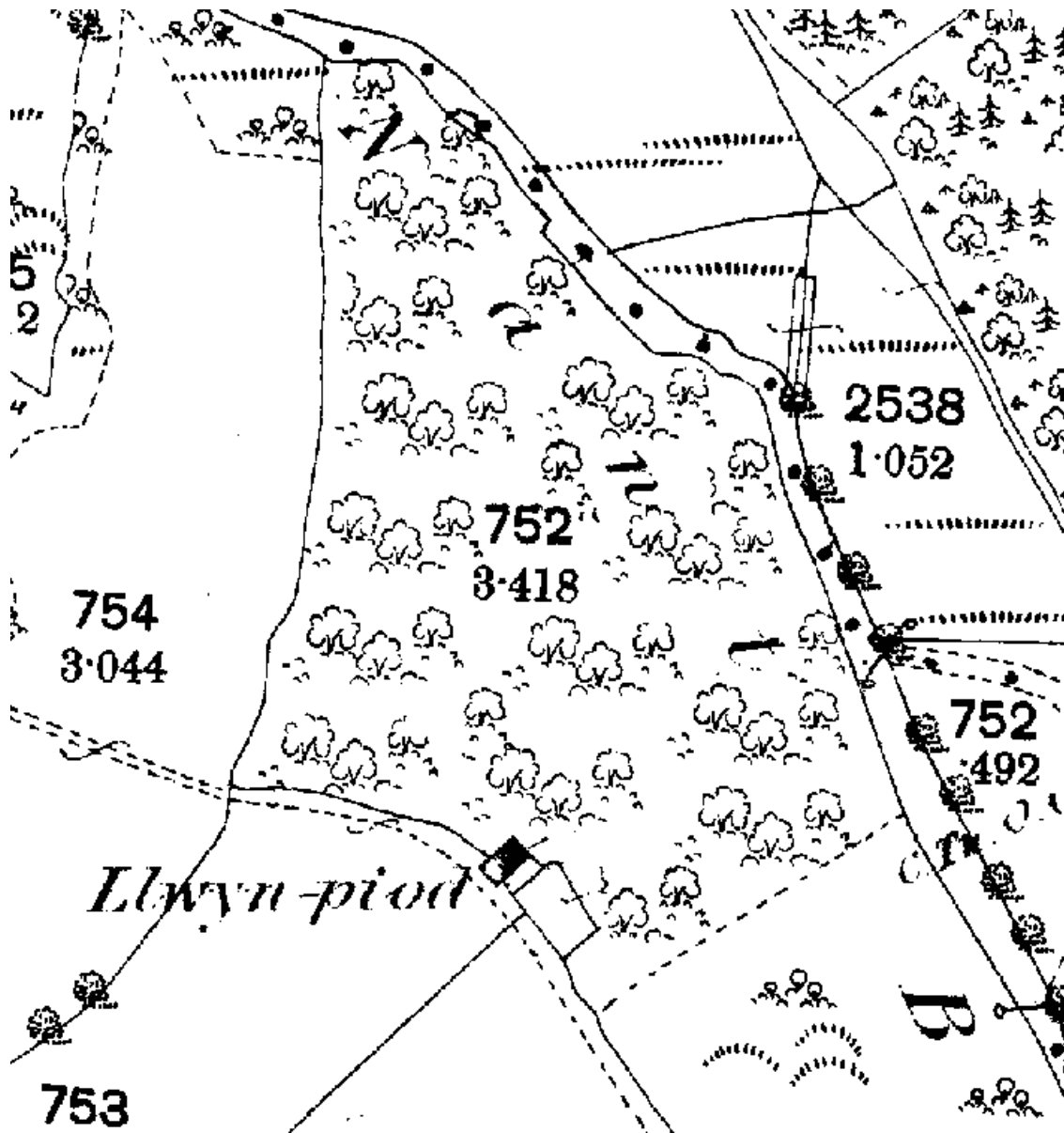
