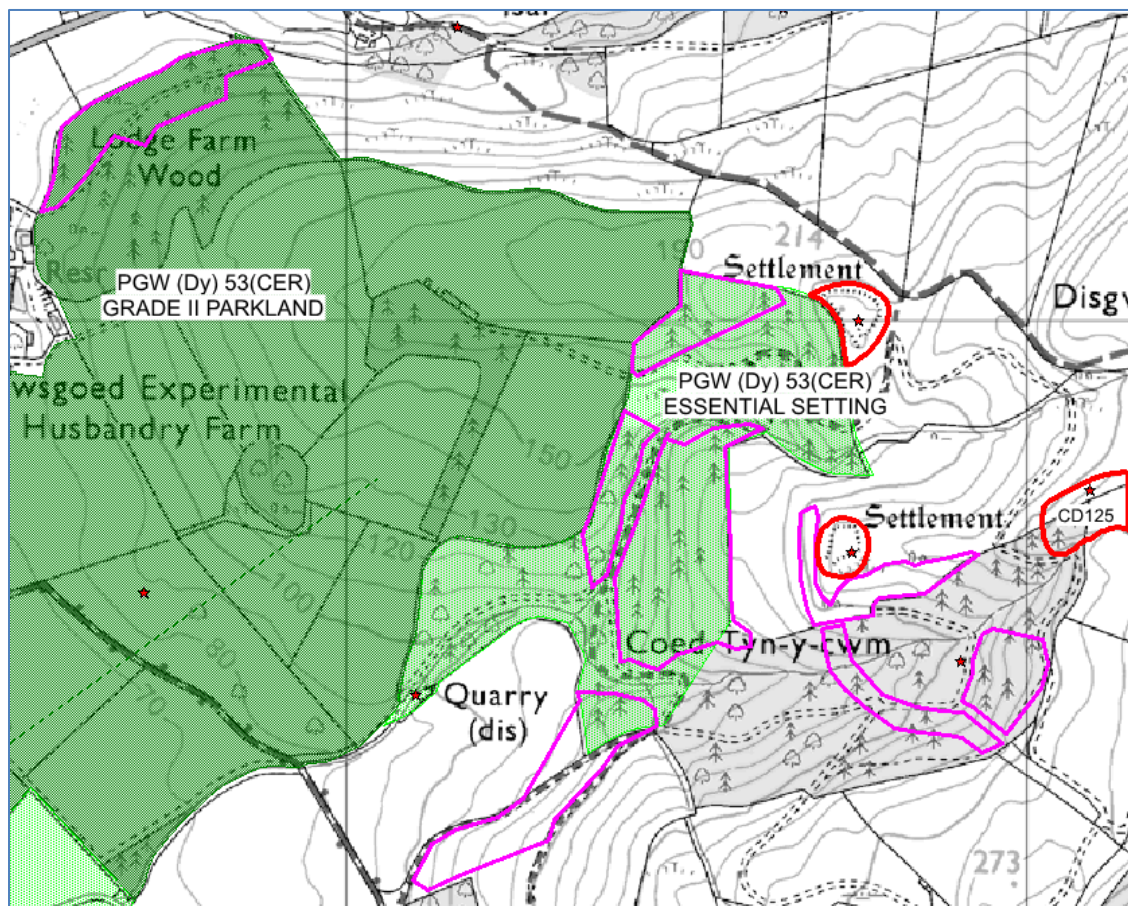

the Trawsgoed Registered Parkland. Consultation should be sought with Cadw regarding the proposals.

Cpt 2j lies adjacent to the Scheduled Monument CD125 Coed Ty'n-y-Cwm Camps, which consists of three Iron Age defended enclosures. Whilst this compartment lies outside the scheduled area, forestry operations, including access or storage, must not impact on the scheduled area, and ideally a buffer of at least 10 metres be employed around the scheduled area.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
