Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment records within the consultation area;

Primary Reference Number (PRN): 11848

**NGR**: SN643655

**Site Type (preferred type first)**: Post Medieval Carved Stone / Medieval Carved Stone / POST MEDIEVAL Carved Stone

Summary :

Found at Cae'r Fynwent, Godregarth, and exhibited by Mr S M Powell at Tregaron in 1931. It is an undressed fragment of local stone on one face of which is a 'trident'. This decoration has been pecked out, not carved. It's date is uncertain. Possibly a mason's mark.

Its current location is not recorded. A similar stone is built into the wall of Tregaron churchyard (PRN 11850)
