A Felling Licence Application has been received by Natural Resources Wales for FLA283/19-20 Llettytwppa near Lampeter

We are consulting with Welsh Archaeological Trusts to screen for potential impacts on historic environment assets in the Historic Environment Records.

The application is for thinning and a small section of clear felling as follows:

Restocking of the small clear felled area will be with Oak and Birch, potentially by Natural Regeneration but by planting if that fails.
