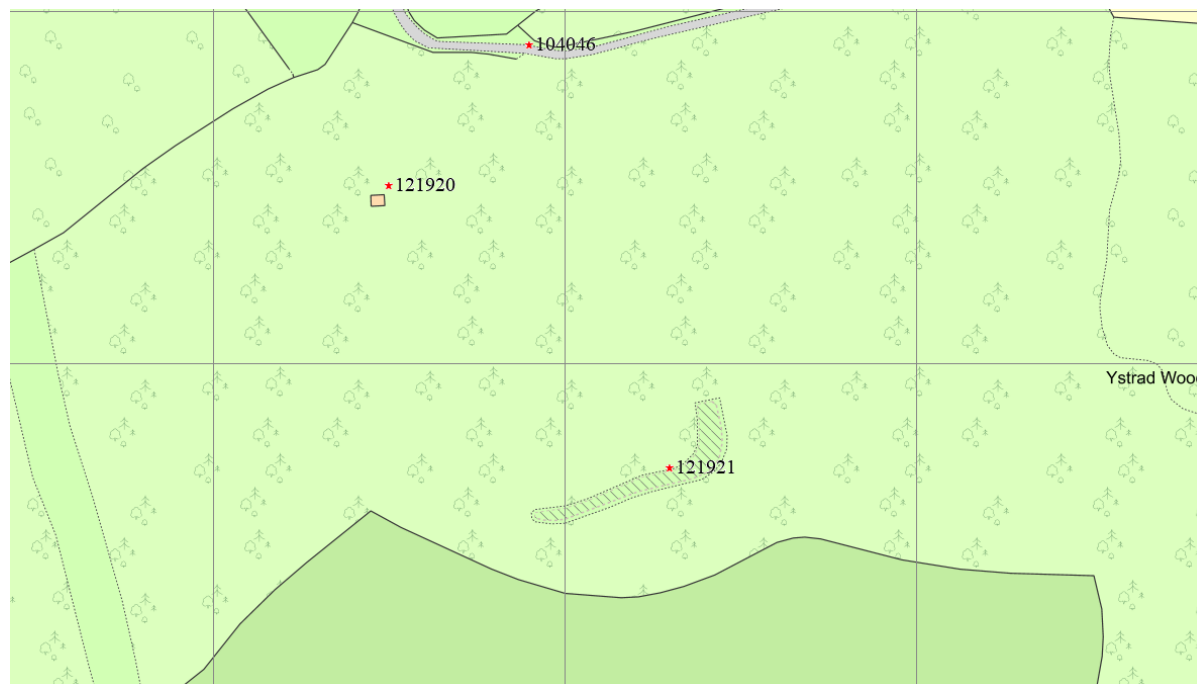

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following records;

PRN 121920 TYPE Water Tank NGR SN39451895
A tank is recorded within Ystrad Wood on the 1st and 2nd edition Ordnance Survey maps (1890 & 1906). The tank is probably a water tank associated with Ystrad house (PRN 20344). A Pyper 2020

PRN 121921 TYPE Quarry NGR SN39531887
A quarry is recorded on the 1st edition Ordnance Survey map, 1890.
