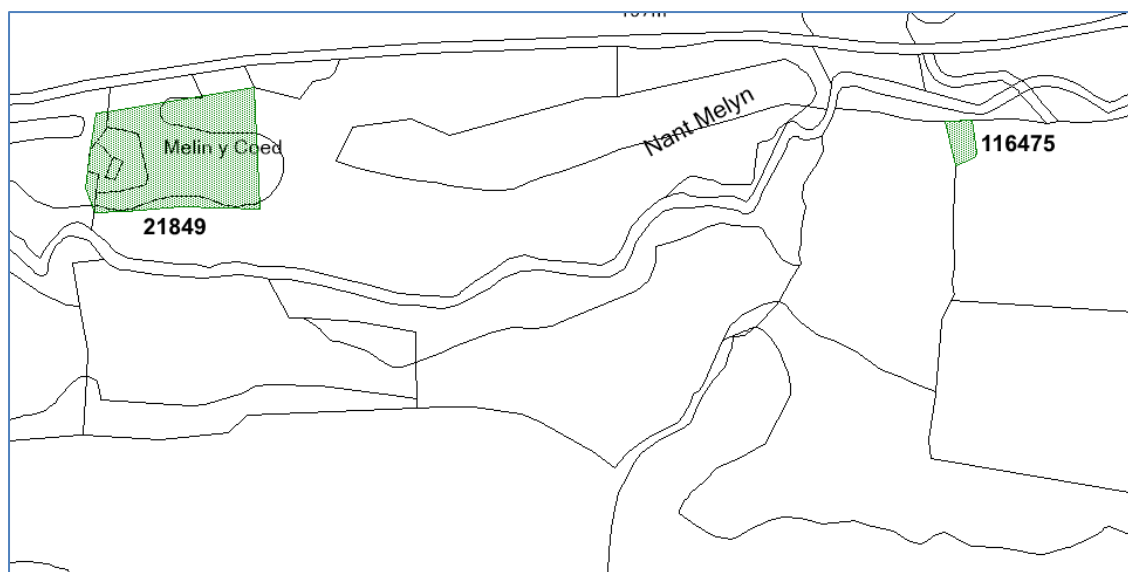

PRN	Summary	Type	NGR
21849	Mill complex recorded on the 1888 1st edition Ordnance Survey map, named 'Melin y coed Woollen Factory'. Marked as disused on the 1905 2nd edition OS map. It is located on the edge of broadleaf woodland by the side of the Nant Melyn. The rectangular building is now roofless and ruinous, measuring approximately 11 metres north-south by 6 metres east-west. The layout of the structure was difficult to determine, with no internal features discernable, but there were possibly two doorways and a central window in the east facing wall - presumably the facade - and one doorway in the northwest corner of the west- facing wall. 
