**FLA 47 20-21 Allt Hengeraint**

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment feature recorded within the consultation area;

PRN 62135

SITE TYPE: PILLBOX (TYPE FW3/24)

PERIOD: MODERN

NGR: SN47076043

DESCRIPTION:

Type 24 pillbox, thin-walled type, with hinged shelf supports (wood) inside. Earth on roof. Very close to recent roadworks cutting, but left intact (Defence of Britain Database 2002).

A reinforced concrete pillbox, dating to the early period of World War II (AD 1940-41). The pillbox is located on the S side of the A482 trunk road, midway between Aberaeron and Ciliau Aeron. It was built on an artificial terrace dug into a steep NW-facing slope, overlooking the main road and the Aeron valley below. The pillbox is built to standard War Office FW3/24 specifications, possessing seven embrasures. It is an irregular hexagon in shape on plan and measures c. 4.5m in length NE-SW by 3.3m transversely and 2.1m in height externally. A Pyper based on Scheduled Monument description CD247.

This pillbox is a scheduled monument and therefore any forestry activities must avoid the scheduled area. Any activities including dumping or felling of trees etc need to be carried out with consent from Cadw. The scheduled area comprises the remains described above and an area in which related evidence may be expected to survive. The scheduled area is circular and measures 20m in diameter and is shown in red on the map below.

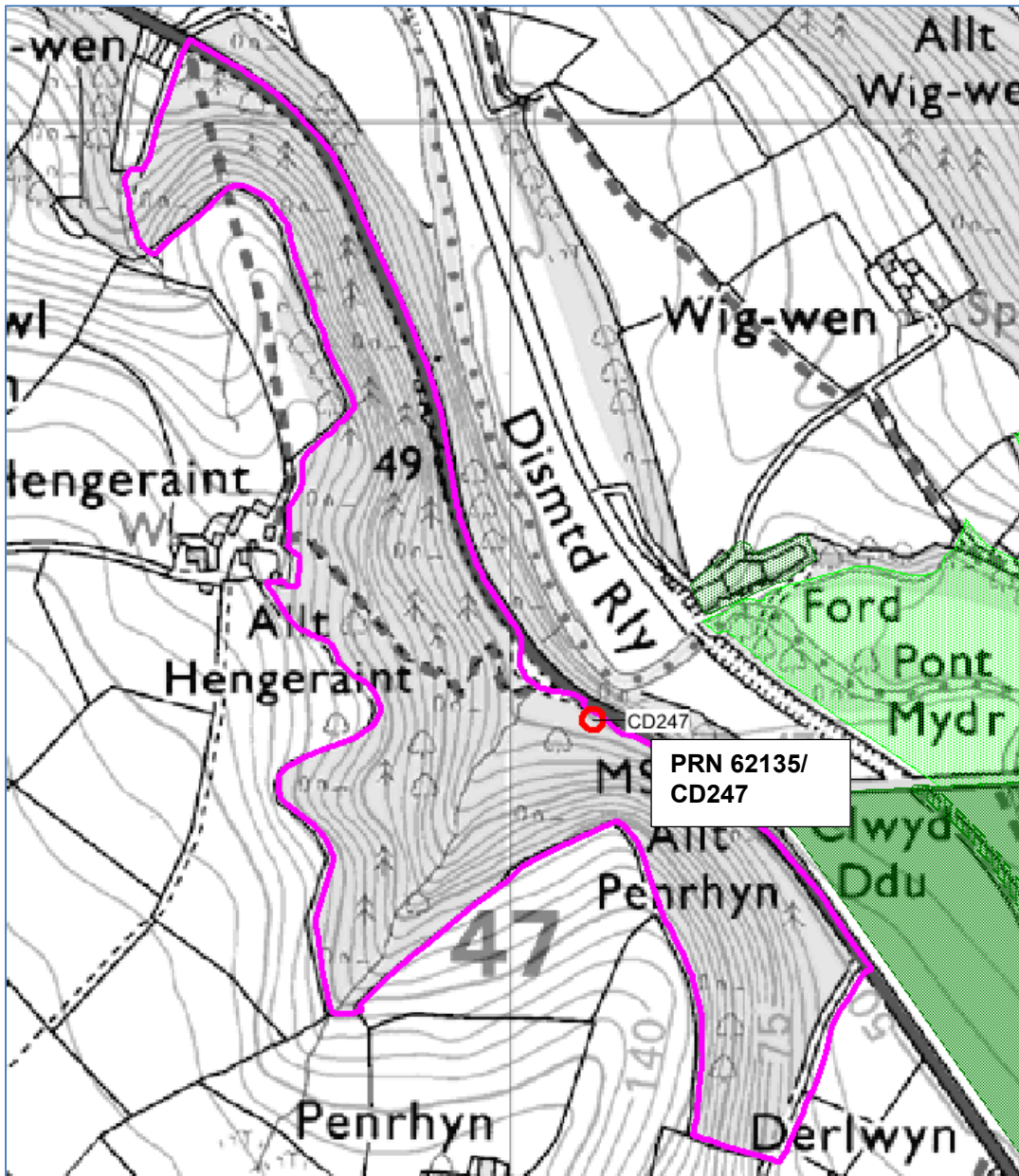
