Thank you for your consultation. I have checked the map provided against the regional Historic Environment Record (HER) and other sources and note the following historic environment features which may be affected by the proposals;

Cpt 2a

PRN: 6057

SITE TYPE: CROPMARK

NGR: SN59405377

SUMMARY DESCRIPTION:

A circular cropmark 28m in diameter identified from aerial photographs, though nothing has been corroborated from a site visit in 1976 when the area was under a conifer plantation. Given the aerial photograph was taken in May it is unlikely that an archaeological site would be defined as a cropmark at that time. A Pyper 2020.

RECOMMENDATIONS:

Given the dubious identification of the site and that no earthwork features were identified on a site visit in 1976, it is unlikely that this is a genuine archaeological site. Should any potential remains be observed then contact Dyfed Archaeological Trust for further advice.

SUMMARY DESCRIPTION:

A former cottage site recorded on the Ordnance Survey 1st edition map (1889) but absent from the recent mapping. It is not known what survives of this site today.

RECOMMENDATIONS:

Forestry operations should ensure that any built structures, or earthwork remains are protected from damage and a buffer of at least 10 metres around any structures should be left unplanted.

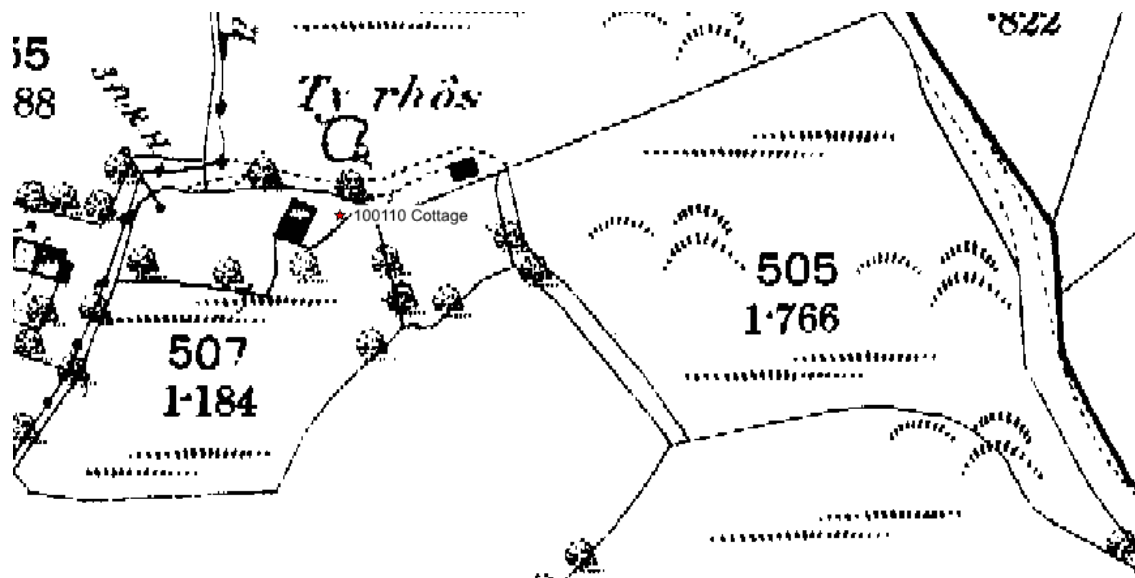

SUMMARY DESCRIPTION:

A former farmstead site recorded on the Ordnance Survey 1st edition map (1889) and shown in outline on the recent mapping suggesting that building ruins may survive at this location today.

RECOMMENDATIONS:

Forestry operations should ensure that any built structures or ruins are protected from damage and a buffer of at least 10 metres around any structures should be left unplanted.

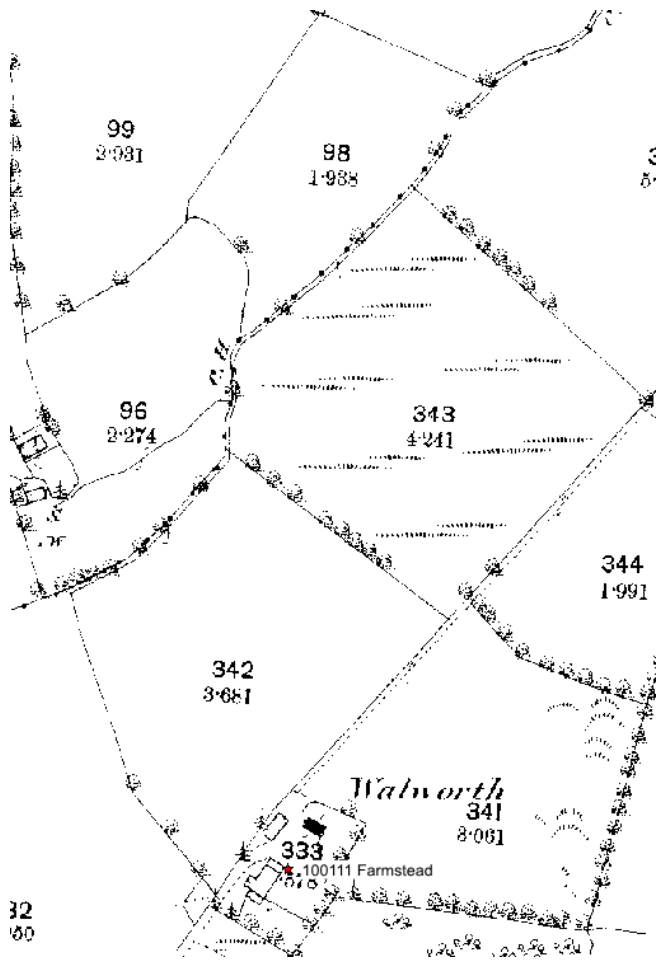
