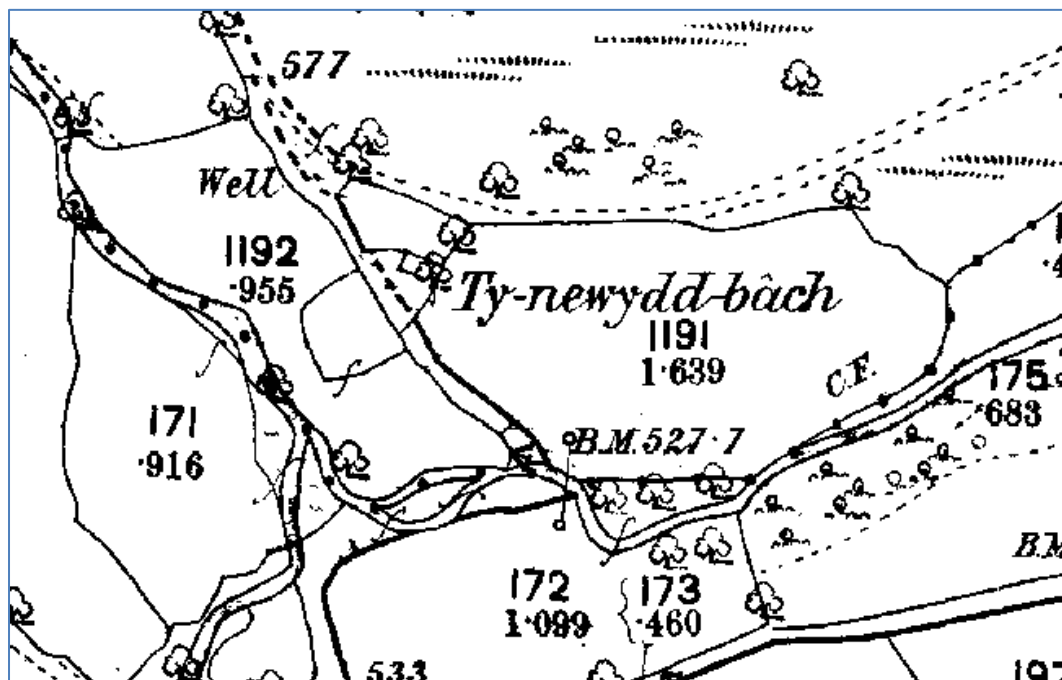

PRN 7479 TYNEWYDD BACH COTTAGE NGR SN7807627755
Cottage marked and named on OS 1886, not on OS 1906. Presumed abandoned between these dates Site obscured by vegetation on recent APs.

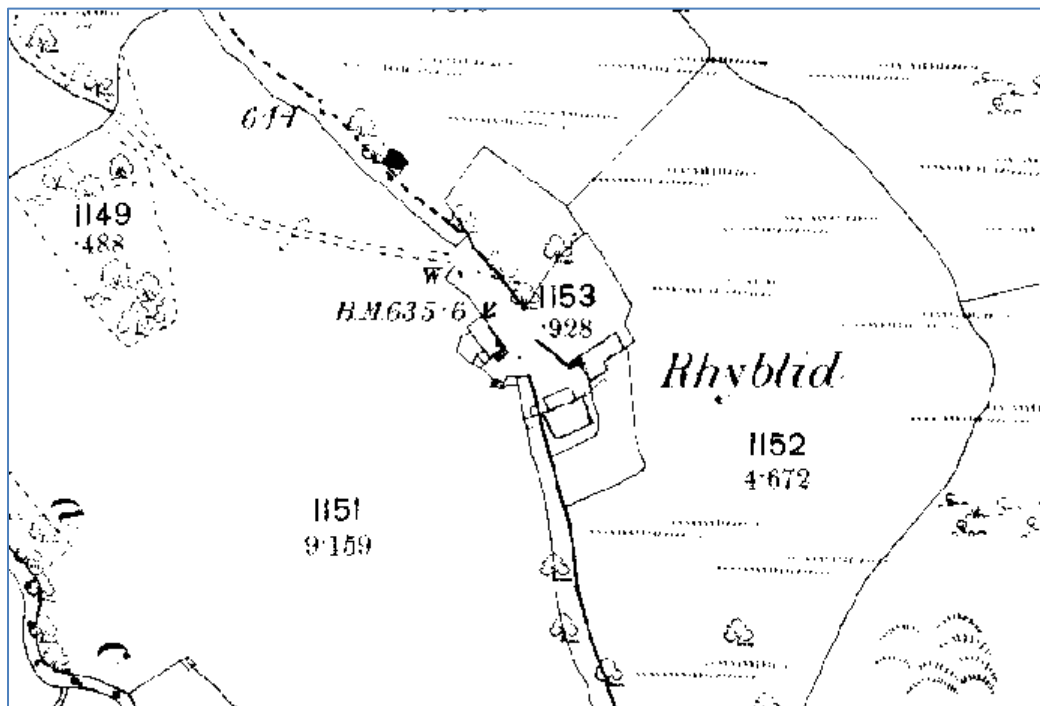

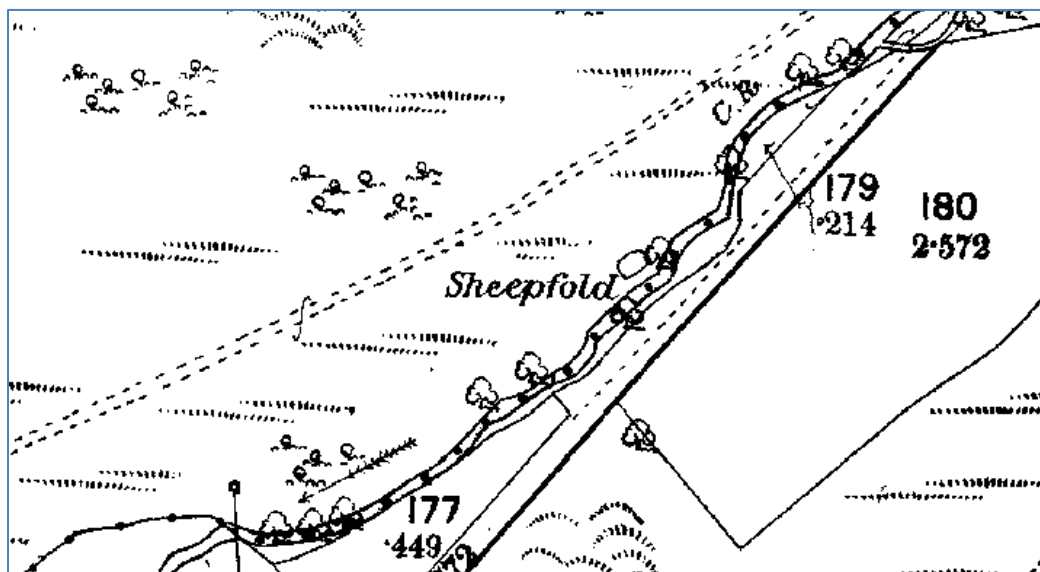


PRN 113702 RHYBLID FARMSTEAD SN7799028078
