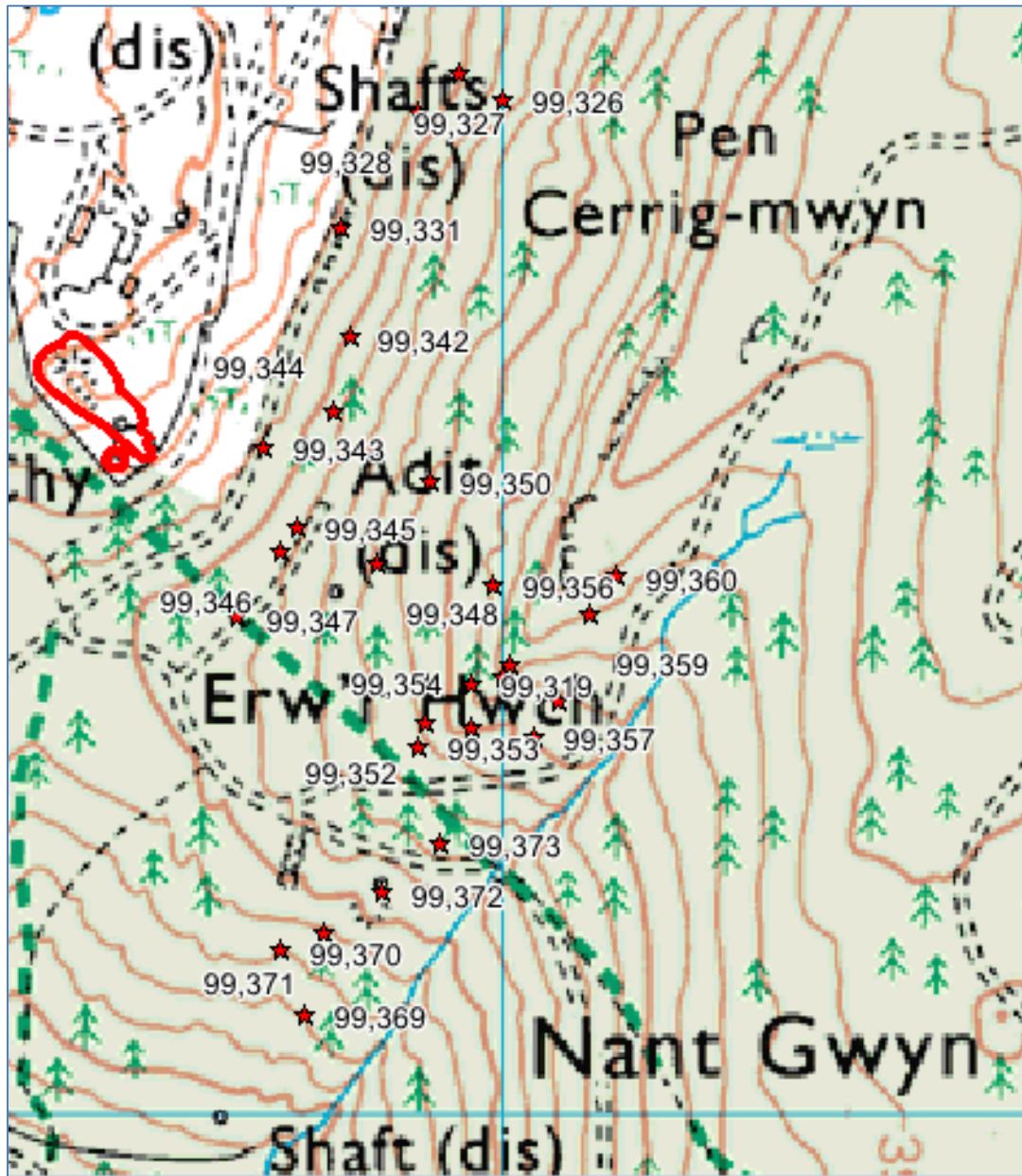

This forest is rich with the historic remains of the Nantymwyn lead mine which includes the earthworks of levels and adits and hushing activity where water was used to flush and expose mineral deposits. These earthworks are very vulnerable to forest operations and great care should be taken to avoid impact of these features. DAT-Heritage Management can provide further information and advice.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust
