Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment features recorded within the consultation area;

5153	CARREG SAMSON;MAEN LLWYD	Standing Stone	Bronze Age	A fine lozenge-shaped standing stone in open moorland, 1.5m high, 1.4m wide and 1m thick. NC 2005.	SN6756853832
11453	WAUN MAENLLWYD	Round Barrow	Bronze Age	A roughly circular grass-covered earth mound, c.15m in diameter and 1.2m high, with a possible ditch present on its W side. Located c.75m NE of Carreg Samson standing stone (5153). NC 2005.	SN67655386
11482	WAUN MAENLLWYD	Round Barrow	Bronze Age	Previously described by DAT in 1986 as a 'Low oval stony mound, 10.2m N-S, 8m E-W, almost directly north of Carreg Samson standing stone (60m).' When the area was visited as part of the PFRS project in 2004 it was impossible to locate this site amongst the long grass. Standing stone 5153 lies c.60m to the S and round barrow 11453 lies c.50m to the ESE. NC 2005.	SN67605387
11483	WAUN MAENLLWYD	Standing Stone	Bronze Age	A recumbent stone, 1m x 0.8m x 0.2m thick, long axis 305 degrees. Located close to standing stone 5153 and barrows 11453 and 11483. NC 2005.	SN67675383
48393	MAEN LLWYD	Prehistoric Monument Complex	Bronze Age	Group prn for Carreg Samson standing stone (5153), round barrows 11453 and 11482, and possible standing stone 11483. NC 2005.	SN67625384

This prehistoric funerary complex appears to lie within a compartment which is not part of the plantation. It is archaeologically a highly sensitive complex and there are likely to be archaeological remains which are not visible and may be vulnerable to damage, therefore forest activities should avoid the area marked out in green in the above map.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
