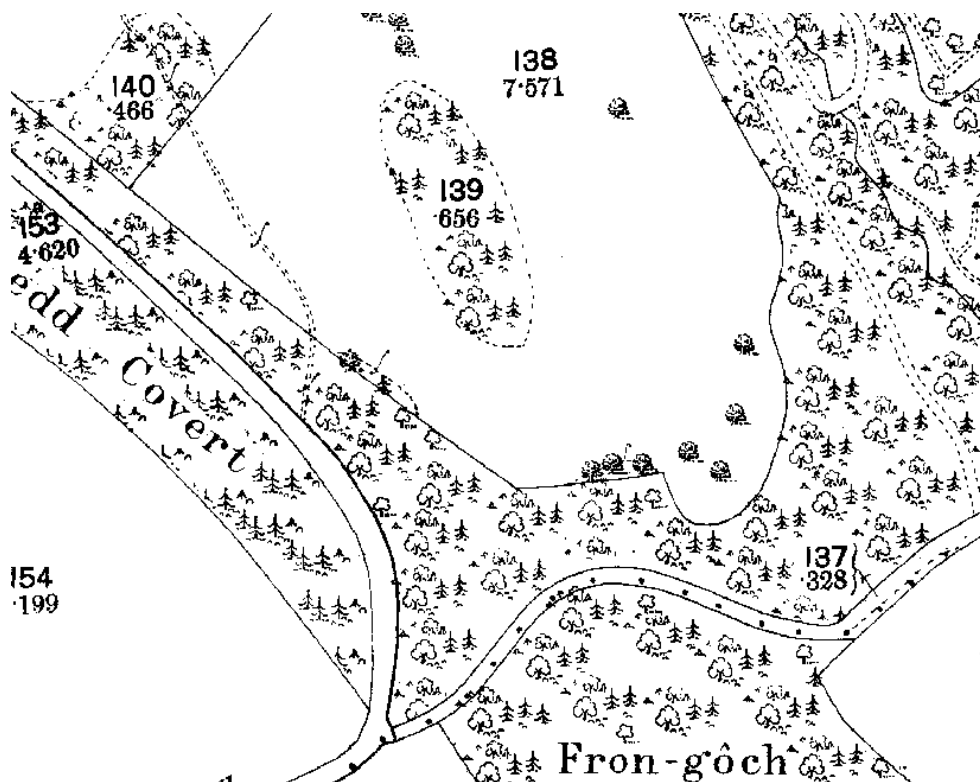

The area for clear felling forms part of a mixed belt which frames an open area of scattered individual, and clumps of, deciduous trees. The former parkland appears to have lost some of its definition in recent times; however these woods form an important surviving element of the park. Forestry operations should endeavour to minimise the visual impact of clear felling as far as possible and retain the historic species profile.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
