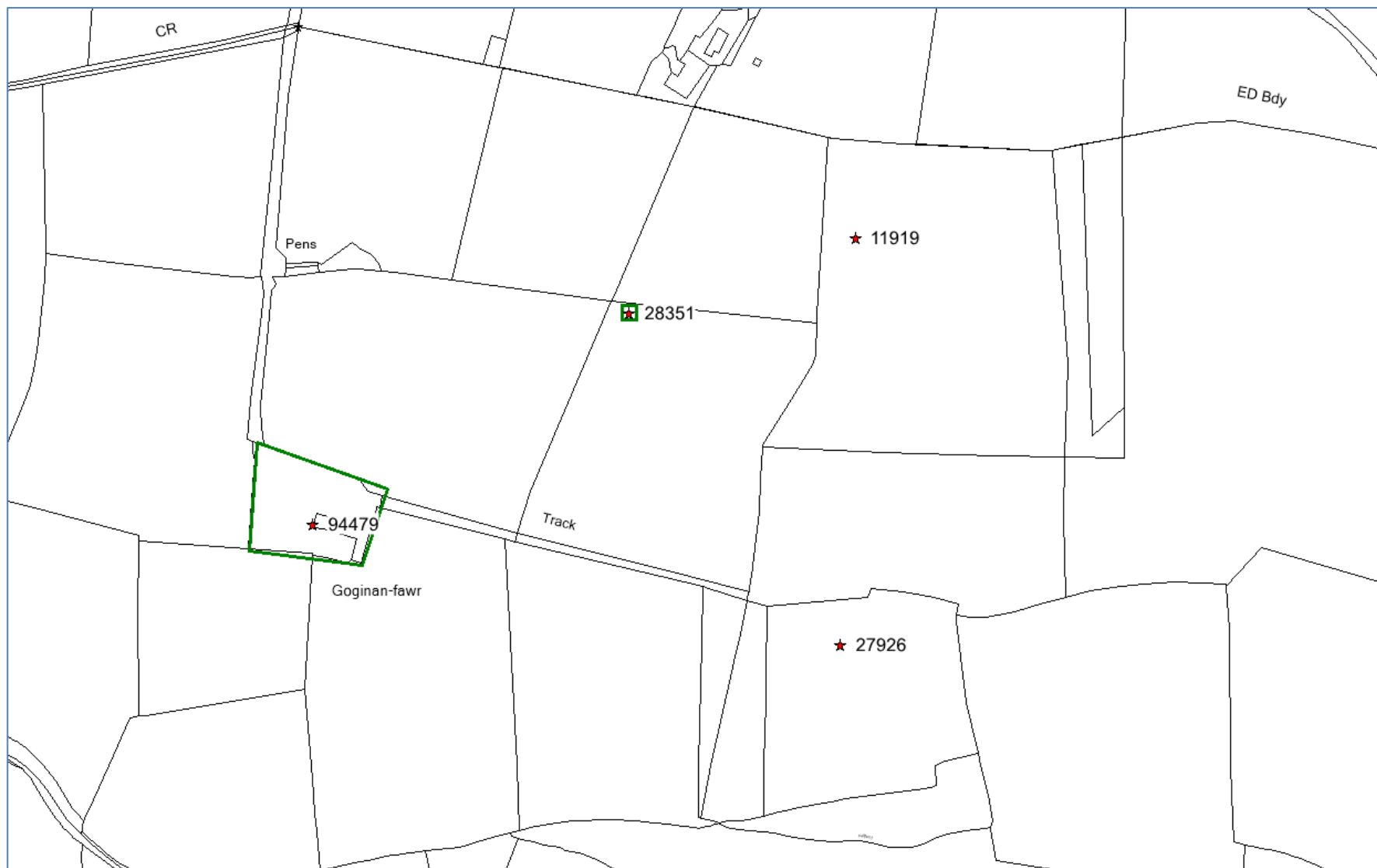

Decision (If the proposal is considered to be inappropriate at this location please provide an explanation)	<p>Thank you for forwarding this Glastir Woodland Creation proposal to us.</p> <p>Dyfed Archaeological Trust have reviewed the new planting proposals for Goginan Fawr against the Historic Environment Records database and other readily available record sources and have assessed that the application, as submitted, has the potential to have an impact upon the following Historic Environment Features (HEF's):</p> <p>PRN 11919 Prehistoric Round Barrow SN68558235 Previously recorded In the SMR as a disturbed round barrow, 10m in diameter and 1.5m high.</p> <p>PRN 28351 Unknown date Platform SN684823 A small platform 3.0m x 10.0m, cut into the hill side. CAS 1987.</p> <p>PRN 27926 Post Medieval Trackway SN68548208 Trackway from Goginan-Fawr to Bwlch Mine. EM 1994.</p> <p>PRN 94479 Post Medieval Farmstead SN68198216 Farmstead depicted on the Ordnance Survey 1st edition map (1888) with an L-plan range of farm buildings and a detached house to the west. The recent Ordnance Survey mapping shows this layout to be essentially unchanged today suggesting good potential for surviving buildings.</p>

	<p>This consultation also lies within the Upland Ceredigion Registered Landscape of Outstanding Historic Interest (HLW (D) 2), which has been further described by the Historic Landscape Character Areas Ysguborneydd and Darren (HLCAs 82 & 61).</p> <p>Dyfed Archaeological Trust name therefore advise that in order to comply with UKFS <i>Forests and the historic environment</i> guidance, the following advice should be adhered to in the Glastir Woodland Creation plan:</p> <p>The prehistoric round barrow PRN11919 lies in a field parcel adjacent to planting area, therefore we recommend that planting should not impinge on the visibility of this site, this could be achieved by not planting too far up the slope, incorporating a soft edge to the planting and incorporating more open ground in the areas nearest the barrow.</p> <p>In addition the other features mentioned above should be protected by not planting the areas outlined in green on the accompanying map.</p>
