4. Design of New Planting

Brief description of new planting site	Planting will be carried out in improved grassland used for sheep grazing situated at approximately 100 near Efailwen in Carmarthenshire. The planting is part of a One Planet Development and will contribute toward sustainable production and self-sufficiency as required by this scheme. Cpt1 is on relatively flat ground with wet, but not waterlogged, mineral soil, cpt2 is also relatively flat but with generally better drained mineral soil. Two small un-named watercourses run along the boundaries of the field parcel, these will not be included in the planting area. The field parcel is surrounded by mature hedgerows and is next to an area of existing native woodland. The nearest dwelling is around 120m from the planting areas and all nearby residential properties are screened by existing mature trees. The planting will not affect the view from any dwellings. There are no public rights of way through the land.
Pre-planting ground preparation	Grass will be kept short by sheep grazing up until the point of planting. Trees will be planted directly with no prior ground preparation.
Design of new planting scheme	<p>Cpt 1 - The species listed in section 7 will be planted in a random pattern with an average spacing of 2m. Shrubs will be planted along the edge of the cpt to provide a woodland edge habitat.</p> <p>Cpt 2 - The species listed in section 7 will be planted at 10.5m spacing (accounting for existing trees – see below) with each tree protected by a post and rail stock guard in compliance with Glastir specifications.</p>
Type of planting stock and size of trees/shrubs	40-60cm bare-rooted stock.
Tree protection – what type of tree shelters/spiral guards will be used and why?	Spiral guards and canes to protect from rabbit and vole damage.
Fencing (livestock)	A new post, wire and netting fence will be erected in compliance with Glastir specifications between cpts 1 and 2, measuring 77m.
Deer protection (if an issue)	There are no significant deer population in the area and deer protection is not required.
Open ground	Powerlines run across cpt 1, a 10m strip of land (0.07ha) under these will be left as mapped open ground and is excluded from the GWC area given in section 7.

Are standing trees present?	There are trees in adjacent woodland and hedges, there will be no planting under the dripline of existing trees which accounts for 0.031ha (6% of the planting area).

Mulch will be applied around each tree at the time of planting and topped up annually as required to suppress weed for 2-3 years after planting or until the trees are established. Grass and weeds beyond the mulch will be cut manually.
Tree replacement	Dead trees will be replaced in accordance with the species mix given in section 7 to ensure there are 2,500 trees/ha in cpt 1 and 80 trees/ha in cpt 2.	The owner and/or a contractor.	Trees will be surveyed in summer for survival and replaced as required in the winter. This will be especially important until the trees are established (expected 3-4 years) but will be continued for the duration of the contract (12 years).
Fencing	Existing and new fencing around cpt 1 and stock guards in cpt 2.	The owner and/or a contractor.	Fence will be checked annually over the GWC contract commitment period (12 years), and repaired as necessary.
Tree protection	Damaged or missing spiral guards and canes will be replaced whilst trees are vulnerable to rabbit damage.	The owner and/or a contractor.	Tree protection will be checked as part of annual tree survival survey.
Removal of tree protection	Tree guards will be removed when the trees are no longer vulnerable to rabbit damage.	The owner and/or a contractor.	Expected to be approximately 8 years after planting.
