4. Design of New Planting

Brief description of new planting site	Planting will be carried out in two fields of improved grassland used for sheep grazing situated at approximately 40 masl near Lampeter Velfrey in Pembrokeshire. The land is relatively flat and adjoins existing areas of woodland. The soil is mineral, cpt 1 is wet but not boggy, cpt 2 is better drained. The landscape is characterised by agriculture with patches of woodland and mature hedgerows. Un-named watercourses flow along the boundaries of the two field parcels but these are already bordered by mature hedgerows and the planting will not affect these. The nearest dwelling is around 80m from the planting areas but this and other nearby houses are screened by existing mature hedgerows and existing woodland. The planting will not affect the view significantly from any dwellings. There are no public rights of ways in or adjacent to the planting area.
Pre-planting ground preparation	The land will either be mounded prior to planting or trees will be planted directly and grass will be kept short by sheep grazing up until the point of planting.
Design of new planting scheme	The species listed in section 7 will be planted in a random pattern in single species groups of around 10-30 trees. Trees will be planted with an average spacing of 1.9m in cpt 1 (to allow for existing trees round the planting area – see below) and 2m in cpt 2. Shrubs (hawthorn, hazel and holly in drier areas and hawthorn, guelder rose, alder buckthorn, spindle, and dogwood in wetter areas) will be planted around the edge of the planting area.
Type of planting stock and size of trees/shrubs	40-60cm bare-rooted stock.
Tree protection – what type of tree shelters/spiral guards will be used and why?	Spiral guards and canes to protect from rabbit and vole damage.
Fencing (livestock)	Post, wire and netting fencing will be erected in compliance with Glastir specifications around the planting area.
Deer protection (if an issue)	There are no significant deer population in the area and deer protection is not required.
Open ground	No open ground is included in the planting area.

Are standing trees present?	There are mature trees present along the boundary of cpt 1, these account for 9% of the planting area (0.027ha). Existing trees have been excluded from the planting area in cpt 2.
