Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note the following historic environment features:

PRN 98695 Post Medieval Cottage NGR SN39733190

Description:

A cottage recorded on the Ordnance Survey 1st edition map (1889, Sheet 23.06, 25"). The cottage is absent from the recent Ordnance Survey mapping, present condition unknown.

PRN 98696 Post Medieval Well NGR SN39733190

A well associated with Lapland Cottage, recoded on the O.S. 1st edition (1889, Sheet 23.06, 25"). Present condition unknown.

PRN 98697 Post Medieval Building NGR SN39583207

A rectangular feature is marked in outline at this location on the Ordnance Survey 1st edition map (1889, Sheet 23.06, 25"). Possible interpretations include an abandoned cottage site or a small enclosure such as a sheep fold for example. Present condition unknown.

PRN 98698 Post Medieval Quarry NGR SN38793137

Quarry recorded on O.S. 1st ed. (1889, Sheet 23.09, 25").

PRN 98699 Post Medieval Building NGR SN38503125

The Ordnance Survey 1st edition map (1889, Sheet 23.09, 25") identifies a rectangular building, possibly a former cottage site at this location. The present condition of the building is not known.

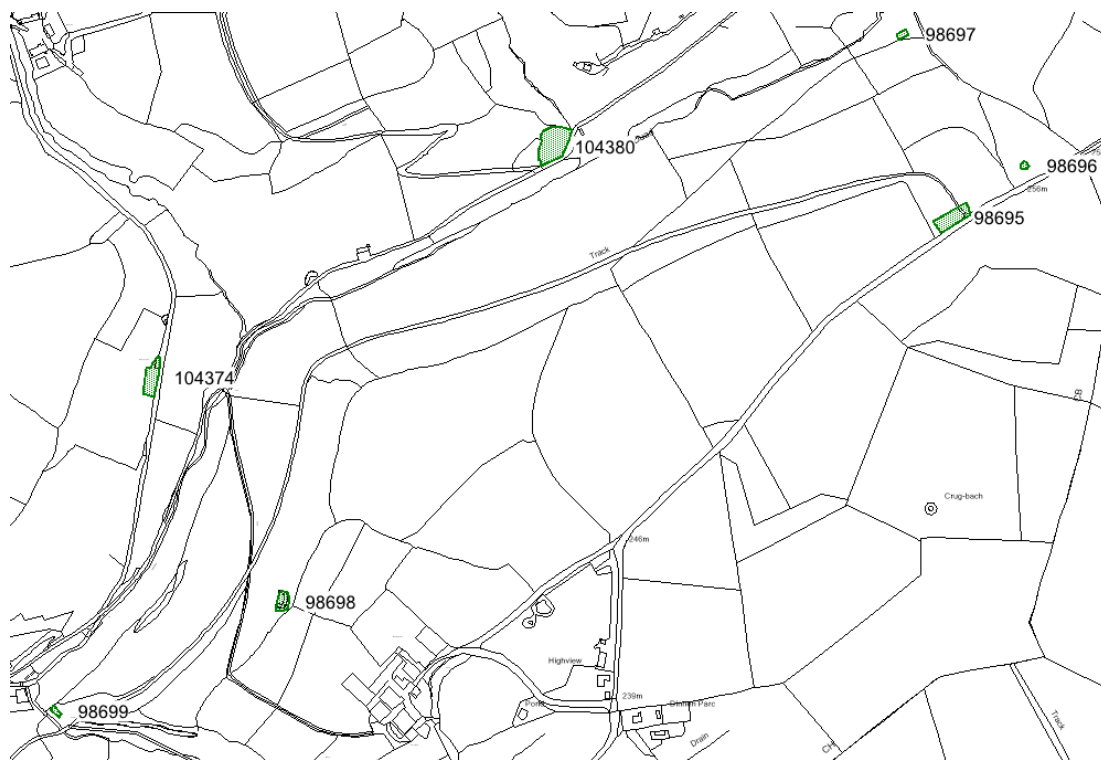
