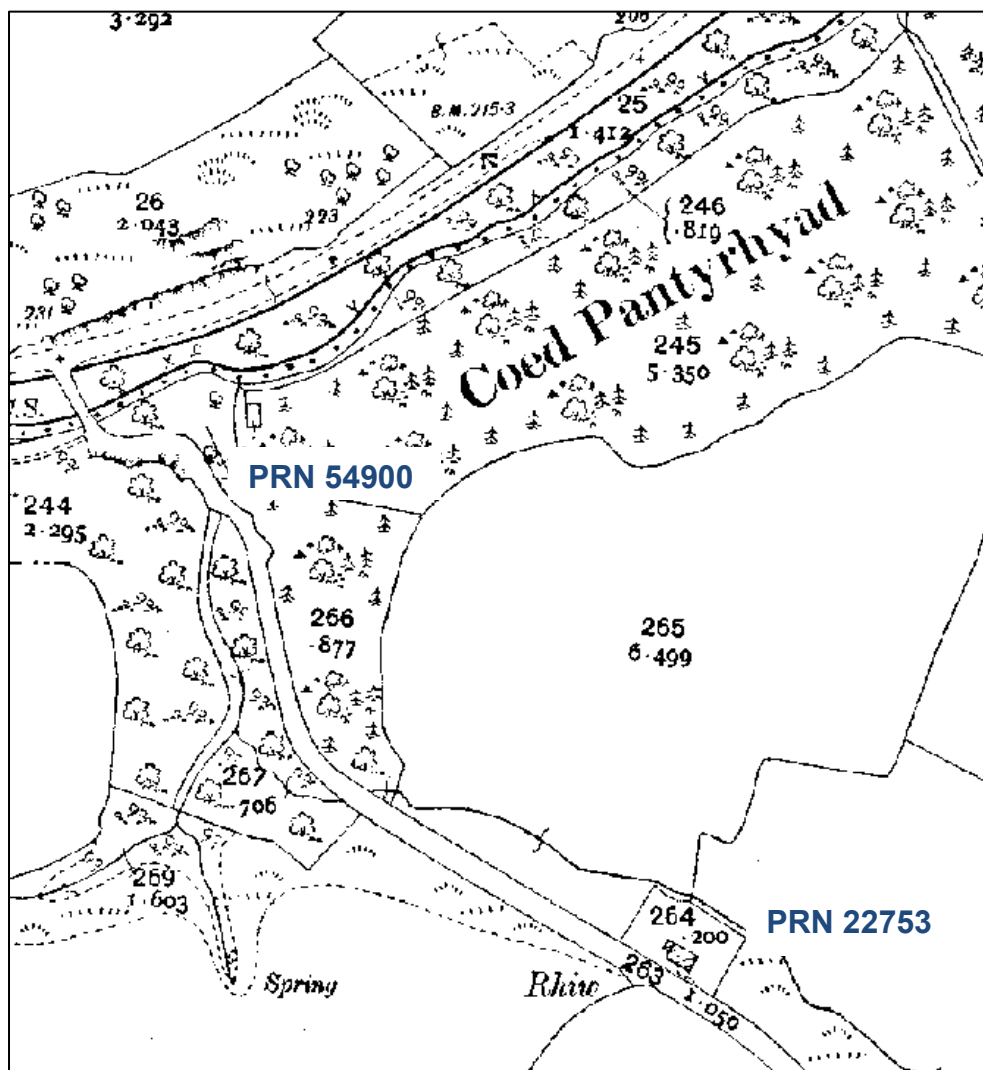


In addition to the designated site, there are a number of other records for Historic Environment features:
