



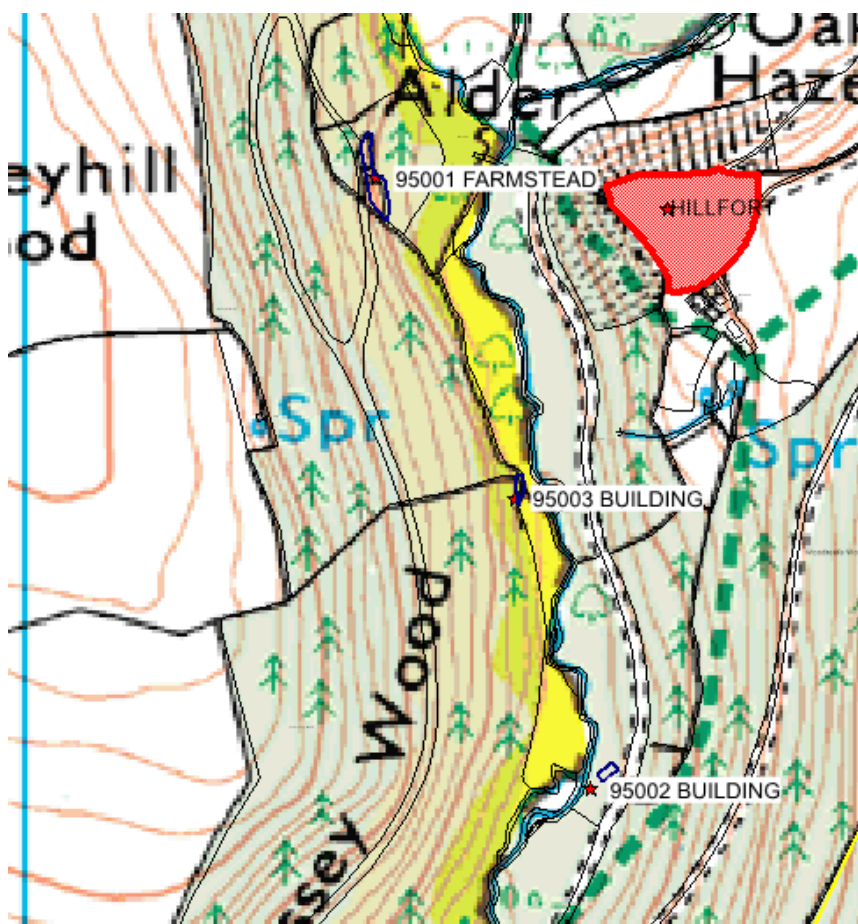



95003	A small building is marked in outline at this location on the Ordnance Survey 1st edition map (1889). W Steele 2009.	Building	SN18320834

The current condition of these features is unknown; however they may survive as ruins, earthworks or below ground archaeology. Felling operations should avoid causing damage in these areas. In addition, the consultation area lies adjacent to a Scheduled Monument (CM253) PRN 3666, the scheduled area is shown in red on the map above. No operations should impinge on the scheduled area without consent from Cadw.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
