

29555	Sheepfold identified from aerial photograph (Meridian Airmaps, 1955). Not recorded on the 1889 1 st edition OS Map or on subsequent mapping.	Sheep Fold	SN12941023
94619	Named as 'Old Quarry' on 1889 1 st edition OS map, suggesting it was disused before the end of the 19 th century.	Quarry	SN12591068

The current condition of these features is unknown, however they may survive as ruins, earthworks or below ground archaeology. Felling operations should avoid causing damage in these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
