



Although outside the consultation area, care should be taken near Scheduled Monument PRN 1861 (CD083) and Cadw should be consulted should felling operations overlap the area.

The current condition of some of these features is unknown; however they may survive as ruins, earthworks or below ground archaeology. Felling operations should avoid causing damage in these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
