

Thank you for your consultation. I have checked the map boundaries against the regional Historic Environment Record (HER) and other sources and note that although there are no features recorded within the consultation area, there is reputedly a medieval chapel PRN 4758 located in this area associated with the nearby Holy Well PRN 102418 (NGR SN58752170), however the whereabouts of the chapel is unknown. If any masonry remains should be noticed during forestry operations, please contact DAT-HM for further advice.
