



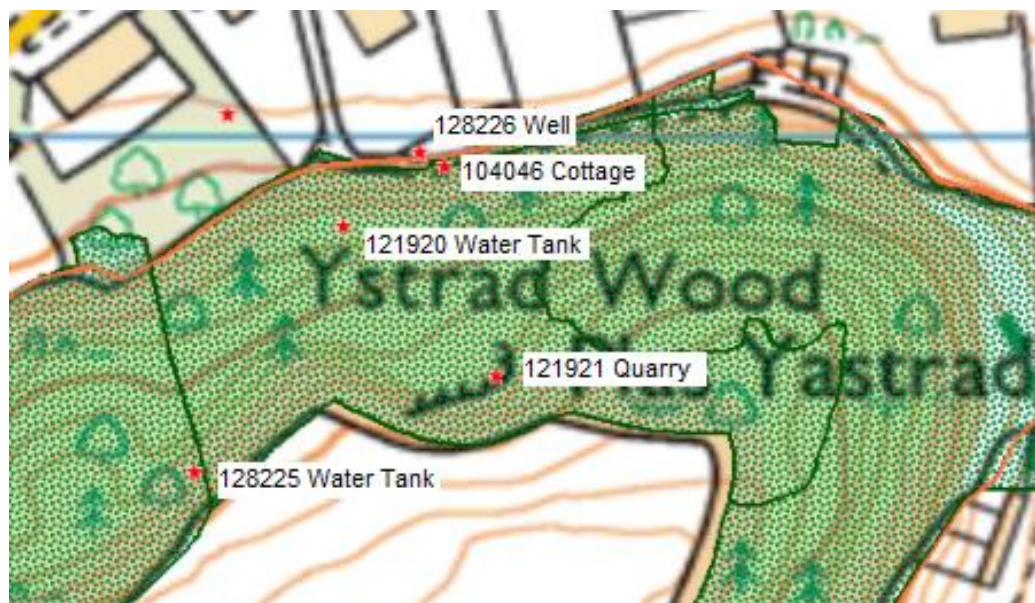



The current condition of these features is unknown; however they may survive as ruins, earthworks or below ground archaeology. Felling operations should avoid causing damage in these areas.
