





Therefore in order to comply with UKFS Forests and the historic environment guidance, DAT advise that these historic environment features (shown on the attached map) must be protected from damage during felling operations and subsequent restocking, and tracks and loading areas must not cross these areas.

There is always the possibility for previously unknown remains to survive within this area of which we have no knowledge. Should further archaeological features or finds be identified it is important that Dyfed Archaeological Trust Heritage Management is informed and further information and advice can then be provided as required.
